A Message from Police Chief Hinig

The Police Department would like to provide the below overview of statistical data related to its major activities for calendar year 2013. Of note is that Part 1 offenses (Major Crime as defined by the FBI's Uniform Crime Report, i.e. Homicide, Aggravated Assault, Rape, Robbery, Burglary, Larceny, Auto Theft and Arson) rose by 38%. Although the percentage seems significant, the actual numbers are not of major concern. In 2012, the Department reported a total of 112 crimes whereas in 2013, the number was 155 criminal offenses.

Crimes against persons remained very low with only six incidents being reported, four of which were a byproduct of the actions of one person. The City had no homicides and no armed robberies during the course of the entire year. Incidents of burglary rose from 42 to 54 and larceny went from 62 to 89 reported events. These latter crimes, commonly called "property crimes," have shown an increase in many cities across California. The total rise in our community is 39 cases over the preceding year. Although there is no single explanation for the upswing, a number of factors were reviewed that may account for the change. First, in several cases, the crimes came in "clusters." This means multiple events (typically 3-5) were committed in a short time frame, usually an overnight occurrence where several vehicles had property removed from them in the same neighborhood, during the same time period, and by the same person.

An additional cause for increased property crime

both locally and regionally is believed to be the State Prison Realignment (AB109) legislation that relocated what are categorized as "non-violent" offenders to County jails. The California Department of Corrections and Rehabilitation reports the State Prison population dropped by 25,000. Although there is yet to be validating statistical data indicating a direct correlation to the inmate releases, what is clear is that these individuals are more prone to commit property related offenses. As such, the Department continues to monitor the peripheral impacts of AB 109.

As property crimes have risen, the Department has reinvigorated its efforts to alert residents to remove valuables from their vehicles, lock car doors at all times, and when leaving their homes, lock the doors and windows and set burglar alarms. Safety measures such as these, coupled with vigilance by neighbors to report suspicious persons or activity, is a proactive and time proven formula for deterring crime.

A hallmark of the agency continues to be its excellent response time. During 2013, the average time for Priority 1 calls (emergency) was 2 minutes and 4 seconds. Priority 2 events (which require an immediate non-emergency response) was 2 minutes and 55 seconds.

Traffic safety throughout the City is of critical importance and remains the number one concern of residents as expressed in calls to the Police Department.

These calls and complaints report unsafe driving, hazardous roadway conditions and parking problems. In response, the Department issued a total of 4,160 citations in 2013, of which 2,680 were for parking offenses. The remainder were related to speed and various other moving and equipment violations. These policing efforts are augmented by the work of the City Traffic Engineer who works in concert with police staff to identify areas where design, signage and traffic calming concepts can be employed to maximize safety throughout the community.


The Department's enforcement, coupled with engineering efforts, is also geared to accident reduction. For the past four years, the accident rate has remained fairly static. There were 72 accidents in 2010, 75 in 2011, 77 in 2012, and in 2013, a total of 73 accidents were investigated. Of the reported accidents, there were 19 with injuries, but no fatal accidents.

Statistical data often needs to be put into perspective. As such, we also analyzed crime statistics from other

cities in the region. One gauge of relative safety for a community is to look at the total number of Part 1 offenses as a ratio in relation to every 1,000 residents. When evaluated in that manner, the level of crimes per 1,000 of population for Peninsula cities is as follows: Rolling Hills (5.91), Palos Verdes Estates (11.39), Rancho Palos Verdes (14.43), Rolling Hills Estates (14.87) and Lomita (23.74). To add some further perspective, the ratio in Torrance is 19.47 and in Redondo Beach the number is 24.84. The latter two cities are based on FBI 2012 data, which is the last available information for those communities.

Based upon our data comparison, Palos Verdes Estates remains as one of the safest cities in the region with an extremely low per capita crime rate. As a final reminder, secure your personal belongings, lock cars and homes and if you see something out of the ordinary, call the police. We encourage all residents to join Neighborhood Watch (NW) which enhances crime prevention by working together. CITY HIRES Two New DIRECTORS

The City of Palos Verdes Estates is pleased to announce the hiring of two new Directors to its leadership team: Finance Director, Russell Morreale, and Planning/Building Director, Sheri Repp-Loadsman. Both are scheduled to commence with the City the first week of March.

Non-Permitted Single-Family Residence Use

palos Verdes Estates is known for its beautiful and tranquil neighborhoods. The peace, quality of life and neighborhood dynamic can be disrupted when homes and properties are used commercially and routinely for private functions. Impacts to the neighborhood include noise, traffic, parking, etc., and as such, the City prohibits the use of any home/property within Palos Verdes Estates for non-residential and/or commercial purposes.

The City's Municipal Code addresses the rental/lease of any property within the City for uses other than for singlefamily purposes:

PVEMC: 18.04.025 "Commercial Events"

Any event located on property which includes a single-family dwelling, anticipating or prepared to accommodate more than twenty people, where the property owner or his or her representative advertises, requests, or charges an admission fee, rental fee, or other form of payment for the use of the property or any facilities or residence located on the property shall be prohibited. Any event held in violation of this section is declared to be a public nuisance punishable as a misdemeanor. Any person owning property found to be in violation of this section and any other person found to have paid for, rented, or otherwise occupied such property in violation of this section shall be jointly and severally liable for any and all penalties that may be imposed pursuant to PVEMC 1.16.010 and/or Chapter 8.48 PVEMC. (Ord. 700 § 2 (Exh. 1), 2012)

The cooperation and compliance of all residents and/or property owners helps in preserving tranquil quality of life in which many in the community take pride.

Additional Waste Bins



The City's current waste hauler, Athens Services, allows two types of waste to be picked up - green waste, which goes into one truck, and trash/

recyclables, which is placed into another truck. Recyclables are then separated from trash at a Materials Recovery Facility.

For green waste, residents are supplied with up to four (4) green waste bins at no cost by Athens. Black

trash bins (32 gallon-35 gallon) for comingled trash and recyclables, however, are to be provided by the residents at their own expense. The black bins may be purchased at any general hardware store.

The City's waste hauler, Athens Services, defines bulky trash as: furniture; appliances; water heaters; refrigerators (compressors removed); stoves; sinks; lawn furniture; doors; windows; screens; mattresses; beds; rugs. Unacceptable items include: construction waste; green waste; hazardous waste; electronic waste.

The Palos Verdes Peninsula's next Annual Household Hazardous Waste (HHW)/Electronics Waste (E-Waste) Roundup will be held Saturday, May 10, 2014 from 9:00 a.m. to 3:00 p.m. at the Rancho Palos

Verdes City Hall/City Yard located at 30940 Hawthorne Boulevard. This event is jointly sponsored by the Los Angeles County Sanitation Districts and the Department of Public Works. The Household Hazardous Waste (HHW) Collection Program provides the opportunity to properly dispose of unwanted household chemicals that cannot be disposed of regularly.

What can you bring?

- Motor Oil, Antifreeze, Paint, Paint Thinner
- Turpentine, Cleaners with Acids or Lye
- Pesticides and Herbicides
- Household and Car Batteries
- Old Computers and Television Sets
- Sharps or Used Needles

As a reminder, the City of Palos Verdes Estates is unable to accept hazardous materials like those listed above; however, electronic waste may continue to be dropped off at the City Streets & Parks Department at 340 Palos Verdes Drive West in PVE, only Monday – Friday between the hours of 8 a.m.-noon.
