The Issue

Shall the City Council approve an amendment to the lease agreement between the City and the Palos Verdes Homes Association to incorporate a waiver of claims for insured losses?

Analysis and Findings

The Palos Verdes Homes Association for many years has occupied the office area at the north end of City Hall under various lease agreements with the City. The current lease has been in place since 1995 and has worked well for both parties over the past 13 years. A copy of the lease is attached to this report. The lease has an evergreen provision, which provides for on-going renewals and annual CPI adjustments to the lease amount.

The Homes Association recently conducted a comprehensive review of their insurance matters. As a result, it was recommended that the City and Association consider modification to the lease agreement to include a waiver in the event of an insured loss. The City insures the City Hall complex through purchased coverage offered by the California Joint Powers Insurance Authority. All of the City's recreational concession properties are also insured under the City's property program. At their option, some of the clubs also purchase additional specialized coverages (e.g. flood, earthquake). The Homes Association also maintains insurance related to their use and occupancy of the premises.

The property coverage through the CJPIA permits agreements made by the Insured member releasing or waiving right to recovery against third parties. With the recommended change to Homes Association lease, if there were a "loss" (fire, water damage, etc.) the proposed modification to the lease means that neither the City nor the Homes Association could make a claim against the other party if the loss was paid for via an insurance policy. We recommend this proposed modification as the City and Golf Club have in place a similar, longstanding waiver with respect to the property insurance coverage.

The City Attorney has drafted the attached amendment and can answer any specific questions regarding the language or applicability of the waiver. The Homes Association Board of Directors has approved the amendment.

Alternatives Available to the City Council

- 1. Approve the lease amendment.
- 2. Decline to approve the lease amendment.

The Issue

Should the City Council:

Adopt Resolution No. R08-04 to declare that the City Public Works Director is authorized to execute Federal Master Agreement No. 07-5283R?

Background and Analysis

Each year limited amounts of federal funding is available to California local agencies for transportation-related projects. In Los Angeles County the pool of funding is allocated by population to the 89 local agencies within the County. If a local agency has projects it would like to construct with federal funds, it applies for funding with both the Metropolitan Transit Authority and the State of California Department of Transportation (Caltrans) to see if a project is eligible. If the amount of funding is granted the funds become "obligated."

Federal funding is typically transferred to an agency on a reimbursement basis, and "obligation" is a way of ensuring that actual federal cash is available to reimburse a local agency for project costs they have already paid. In the case of Federal Highway Administration (FHWA) related projects on highways and streets, the authority to approve fund obligation is passed on to Caltrans. Caltrans has specific processes that must be followed for an agency to get to a point where funds can be obligated. These vary depending on the program but generally include submitting a "project authorization request" and/or entering into an agreement with Caltrans. Any work performed on the project before receiving authorization to proceed is not eligible for reimbursement.

An agency must ensure it has adequate cash flow to cover planned project expenditures. Generally, once expenditures are incurred on an authorized project, the agency can request reimbursement for those costs. If the agency is required to provide matching monies to the federal funds, those must be

spent first. Once the project is complete Caltrans may have to conduct an audit to ensure funds were spent in accordance with the grant or funding program guidelines.

In early 2007 staff applied for federal aid with Caltrans to construct an overlay street improvement project and a slurry seal street improvement project. The overlay project would occur on Via Campesina from Palos Verdes Drive North to the edge of the new pavement at the east golf course entrance, as well as in front of Via Zumaya next to 2564 Palos Verdes Drive West. The slurry seal project would occur on Palos Verdes Drive North from the triangle intersection to Paseo Del Campo as well as on Via Valmonte from Palos Verdes Drive North to Via Azalea.

In November, 2007, Caltrans informed staff that federal aid was approved for the overlay project. On January 12 staff received two copies of Master Agreement No. 07-5283R and two copies of Program Supplement No. N002 for this project. Caltrans requests that the signed agreements and program supplements be returned to them along with a certified resolution identifying the official authorized to execute the agreements. To expedite the federal funding process, because a majority of the federally required documentation will be generated in the Public Works Department, staff recommends that the City Director of Public Works be identified as the official authorized to execute the agreements and any other documents or instruments pertaining to this federal project.

Alternatives Available to Council

The following alternatives are available to the City Council:

Recommendation from Staff

Fiscal Impact

The cost estimate for this project is \$94,503 and staff requested \$67,000 of federal aid reimbursement. The City will have to ensure that adequate funding will be available to pay for project costs as they occur and must match at least 11.5% of the total funding spent; however, future fiscal savings would result from the City being reimbursed for a significant portion of those costs.

The Issue

Should the City Council adopt:

- a) Resolution R08-01, declaring that weeds growing upon and in front of, and brush, rubbish, refuse, and dirt upon and in front of certain unimproved private properties in the City are a public nuisance and declaring its intention to provide for the abatement thereof, and setting a protest hearing on February 26, 2008; and
- b) Resolution R08-02, declaring that weeds growing upon and in front of, and brush, rubbish, refuse, and dirt upon and in front of certain improved private properties in the City are a public nuisance and declaring its intention to provide for the abatement thereof, and setting a protest hearing on February 26, 2008?

Background and Analysis

Unimproved Lots

The Los Angeles County Department of Agricultural Commissioner and Weights and Measures has provided the City with its annual list of properties for the weed abatement service. Each year, vacant private lots are inspected by the County with a notice provided for property owners to reduce the amount of nuisance vegetation. By law, each City is required to hold a public hearing, allowing property owners to protest the County's assessment of their property prior to the County's tilling and removal of the vegetation/rubbish.

The County annually requests the City to approve a weed abatement resolution, declaring that hazardous conditions upon or in front of the parcels identified by the County are a public nuisance. The County has sent each property owner identified on the attached 'Weed Abatement Declaration List' a notice of the scheduled dates of the resolution adoption and the following protest public hearing.

The County begins the weed abatement process by tilling accessible areas with a tractor disc. Areas that a tractor disc cannot reach are then tilled by hand. Nearly all lots in the City are cleared by machine; only a few require hand work. The work occurs in mid to late spring. When completed, the County requests the City Council to confirm the fees that have been assessed for the weed abatement work, and individual property owners are billed for the fees associated with their properties.

Improved Lots

The Los Angeles County Fire Department has provided the City with its annual list of improved properties for the weed abatement service. These properties listed represent a potential fire hazard. The LACFD notifies all property owners on the list of this potential prior to making a final determination of which properties are a definite fire hazard. The hope is that owners, once alerted to the danger, will clear vegetation before the fire season begins. The process for improved parcels calls for the LACFD to inspect those properties on the list in June and return to the City for authorization to fine for any violations found. The standards that the LACFD uses are different from those used for unimproved lots (see the attached notices from each department). In the past, all problem areas have been resolved and the County has not had to come back to request further punitive action.

Alternatives Available to Council

The following alternatives are available to Council:

- 1. a) Approve Resolution R08-01 declaring that weeds growing upon and in front of, and brush, rubbish, refuse, and dirt upon and in front of certain unimproved private properties in the City are a public nuisance and declaring its intention to provide for the abatement thereof, and setting a protest hearing on February 26, 2008;
 - b) Approve Resolution R08-02 declaring that weeds growing upon and front of, and brush, rubbish, refuse, and dirt upon and in front of certain improved private properties in the City are a public nuisance and declaring its intention to provide for the abatement thereof, and setting a protest hearing on February 26, 2008.
- 2. Decline to act at this time.

Conclusions and Recommendations

Staff recommends the City Council approve Resolutions R08-01 and R08-02, setting protest hearings for February 26, 2008.

Budget Impacts

There will be no budget impact to the City. Charges for inspection and weed abatement procedures within the city are assessed by the County Agricultural Commissioner and the LACFD and directly billed to respective property owners.

The number of improved and unimproved parcels are shown below and compared to earlier years' results.

- Staff is to work with the Planning Commission to further define a reasonable time and place for the neighborhood meeting.

ENDING JUNE 30, 2007 AND FISCAL HEALTH REPORT 1997-2007

The Issue

Shall the City Council receive and file the City's Comprehensive Annual Financial Report (CAFR) for the period ending June 30, 2007 and the City's Fiscal Health Report 1997-2007?

Analysis and Findings

This annual financial report, prepared by the City's Finance Department with assistance of our auditors, Mayer, Hoffman McCann, P.C., covers the results of City operations for Fiscal Year 2006-07. The financial report was transmitted for the Council's preliminary review on December 14th. The Fiscal Health Report is transmitted at this time.

On February 5, 2008, Mr. Ken Al-Imam, partner of the audit firm, and staff met with Mayor Pro Tem Sherwood, representing the Audit Committee, to review the financial report; the auditor's conduct of the audit and their findings. The auditors provided an unqualified (clean) opinion and based on the scope of their review, no deficiencies in internal controls were noted.

The Fiscal Health Report graphs selected financial factors and rates the factors based on an established trend. This report contains the results of operation for FY 2006-07, as confirmed by the auditors. A reading of the audit's transmittal letter, Management Discussion and Analysis (page 3 of audit) and the Fiscal Health Report transmittal letter provides an interested reader the most comprehensive information.

As part of this agenda item, staff will verbally present highlights from the audit and the Fiscal Health Report.

Recommendation

It is recommended that the City Council receive and file the Comprehensive Annual Financial Report for the period ending June 30, 2007 and the Fiscal Health Report 1997-2007.
