OVERVIEW

During this month there were eleven Part 1 crimes. This consisted of four burglaries, six larcenies and a stolen vehicle. Of the burglaries, one was from a residence and the suspect is the estranged grandson; two burglaries were residential construction sites; one burglary was an attempted burglary at a church. Of the larcenies, three occurred on Paseo Del Mar in which the suspect located a hidden key and used it to gain access to the vehicle; one larceny was from an unlocked car; one larceny was a vehicle burglary at the PV Tennis Club. The only stolen vehicle was a Jeep.
