OVERVIEW


During December of 2019, there were seven Part I Crimes; four were residential burglaries, two were thefts from vehicles, and one was a theft of property from a residence.

Of the burglaries, one occurred while the resident was away from their home. The suspect(s) in this case smashed the rear bedroom window to gain entry and ransacked several bedrooms. In the second case, the suspect(s) attempted to gain entry to the residence by prying open door handles of the rear French doors. The suspect(s) were unsuccessful and fled the location. In the third case, the suspect entered an unlocked vehicle where he gained access to a garage door opener left inside. The suspect proceeded to open the garage door to the residence where he removed property from the victim's garage. In this last case, the suspect smashed a rear window to gain access into the residence. Officers responded to the location and subsequently arrested the suspect.

Of the larcenies, two were from unsecured vehicles where the suspect(s) entered the vehicles and removed the victims' property. The third larceny occurred at a residence where property was removed without permission.
