Recommendation

It is recommended that the City Council adopt Resolution R20-40, Reciting the Facts of the General Municipal Election Held on November 3, 2020, Declaring the Results and Such Other Matters as Provided by Law.

Summary and Background

The City Council utilized the services of the Los Angeles County Registrar-Recorder/County Clerk (LACRRCC) to conduct the City's General Municipal Election held on November 3, 2020. The LACRRCC conducted the election on the City's behalf providing services including, but not limited to printing and distribution of the Official Sample Ballot to all registered voters of the City; distribution of Vote-by-Mail materials and ballots; consolidating precincts and establishing Election Day polling places; securing poll workers; Election Day services, and conducting the official canvass.

A summary of the final election results, as reported by the LACRRCC, is included as "Exhibit A" to Resolution R20-40. Members of the City Council elected to a term of four years are James "Jim" Roos and Dawn Murdock. The City Treasurer elected to a term of four years is Katherine "Kate" Greenberg.

RESOLUTION NO. R20-40

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 3, 2020, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted by the Los Angeles County Recorder/Registrar on Tuesday, November 3, 2020, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast and received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the County of Los Angeles Recorder/Registrar canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as **Exhibit A.**

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. *City Council Ballots*. That the whole number of ballots cast in the precincts except vote by mail voter ballots and provisional ballots was 2,002. That whole number of vote by mail ballots cast in the City was 7,565, making a total of 9,567 ballots cast in the City for the election for Members of the City Council.

SECTION 2. The name of persons voted for at the election for Member of the City Council are as follows:

James "Jim" Roos	3,938
Dawn Murdock	3,777
Sanford Davidson	2,676
Gayne Brenneman	2,093
William "Bill" Sewell	1,561

SECTION 3. *City Treasurer Ballots*. That the whole number of ballots cast in the precincts except vote by mail voter ballots and provisional ballots was 2,002. That whole number of vote by mail ballots cast in the City was 7,586, making a total of 9,588 ballots cast in the City for the election for City Treasurer.

SECTION 4. The name of person voted for at the election for City Treasurer is as follows:

Katherine "Kate" Greenberg 6,244

SECTION 5. That number of votes given at each precinct and the number of votes given in the City to each of the persons above names for the respective offices for which the persons were candidates were as listed on **Exhibit A.**

SECTION 6. The City Council does declare and determine that:

James "Jim" Roos was elected as Member of the City Council for the full term of four years;

Dawn Murdock was elected as Member of the City Council for the full term of four years; and

Katherine "Kate" Greenberg was elected City Treasurer for the full term of four years.

SECTION 7. The City Clerk shall enter on the records of the City Council of the City, a statement of the results of the election, showing 1) the whole number of ballots cast in the City; 2) the names of the persons voted for; 3) for what office each person was voted for; 4) the number of votes given at each precinct to each person; and 5) the total number of votes given to each person.

SECTION 8. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 9. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
