CRIME DATA

In May of 2021, there were eleven Part I Crimes; one residential burglary, one sexual assault, one theft of a motor vehicle, three thefts from a motor vehicle, two thefts of motor vehicle parts, and three property thefts.

During the burglary, the suspect gained entry into the residence through an unlocked side garage door. The suspect was observed during the commission of the burglary and reporting party contacted the PVEPD to report the incident. PVEPD Officers responded to the location and subsequently arrested the suspect for burglary.

The sexual assault involved a suspect and victim who had a previous romantic relationship. The case was investigated and will be presented to the Los Angeles County DA's Office for filing consideration


The motor vehicle theft occurred when unknown suspect(s) gained entry into the victim's vehicle by unknown means. The suspect(s) fled the area with the vehicle undetected.

Of the larcenies, one occurred when the victim placed their skateboard down upon entering a local establishment. The suspect removed the skateboard from the location and fled the area. In the second larceny, the victim placed their backpack along the shoreline while surfing. The suspect(s) removed the backpack and fled the location. In the third larceny, unknown suspect(s) removed unspecified mail from the victim's mailbox. Suspect(s) altered the victim's information and obtained checks and currency.

Of the thefts from motor vehicles, two of the vehicles were unlocked when the suspect(s) entered and removed the victims' property undetected. In the last theft from a motor vehicle, unknown suspect(s) manipulated the vehicle door lock and gained entry into the vehicle. Suspect(s) removed property and fled the area undetected.

In the theft of motor vehicle parts, the suspects removed one catalytic converter from a vehicle and attempted to remove the catalytic converter from another. The suspects in this case were later arrested after a vehicle pursuit through three different South Bay cities.






