CRIME DATA

In June of 2021, there were ten Part I Crimes; one residential burglary, one theft of a motor vehicle, three thefts from a motor vehicle, two thefts of motor vehicle parts, and three property thefts.

The burglary occurred when the suspect(s) gained entry into the residence by smashing a third-story balcony door. The suspect(s) specifically targeted and ransacked the master bedroom. The suspect(s) fled the location undetected with the victim’s property.

The motor vehicle theft occurred when unknown suspect(s) gained entry into the victim’s vehicle by unknown means. The suspect(s) fled the area with the vehicle undetected.

Of the larcenies, one occurred when the victims left their residence for approximately three days. The suspect(s) gained entry into the backyard of the residence by unknown means and removed an unsecured gas-powered generator from the backyard. Suspect(s) fled the area undetected with the victim's property.

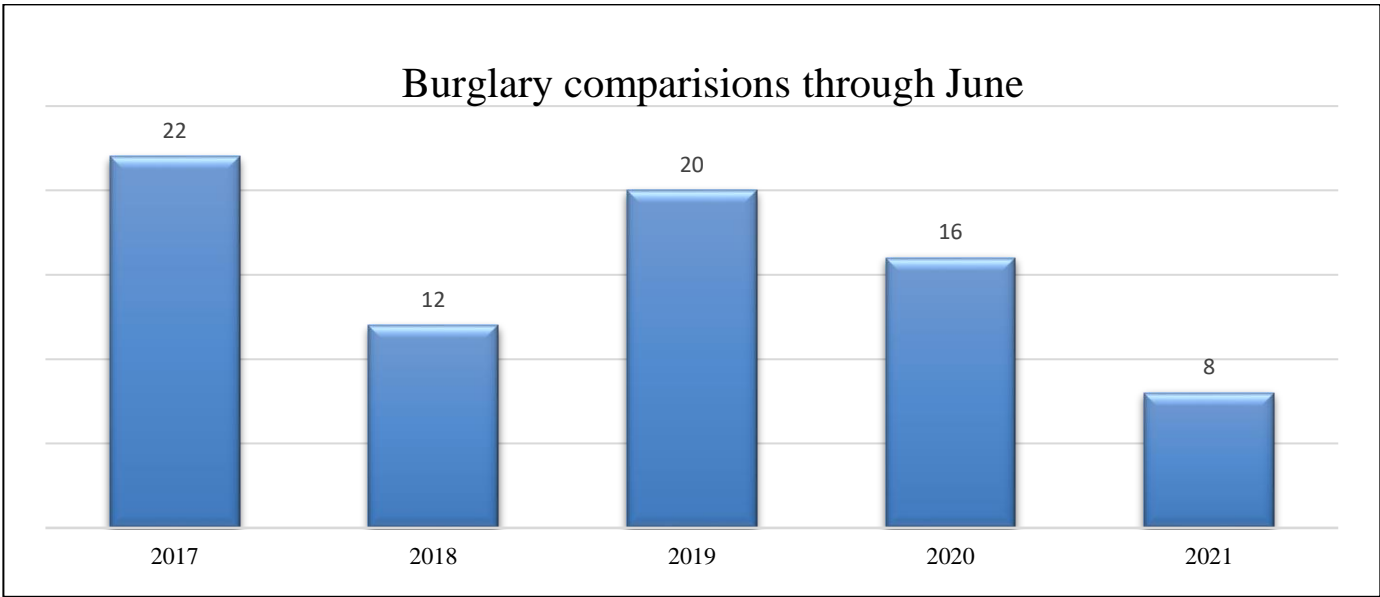
In the second larceny, United Parcel Service delivered a package on a resident's front porch. Unknown suspect(s) are observed on video surveillance parking in front of the residence immediately after the package is delivered. The suspect(s) proceeded to remove the package from the victim's front porch and fled the area with the victim's property.

In the third and last larceny, the suspect entered the victim's property by an unknown means. The suspect removes alcoholic beverages from the victim's outdoor refrigerator and consumes the beverage while on the property. PVEPD Officers responded to the area where the suspect was subsequently arrested.

Of the thefts from motor vehicles, two were from locked vehicles and one was from an unlocked vehicle. In all three cases, the suspect(s) evented the vehicles, removed property, and fled the area undetected

In the theft of motor vehicle parts, the suspects removed catalytic converters from two separate vehicles, from two separate locations. The suspects fled the area undetected with the victims' property.

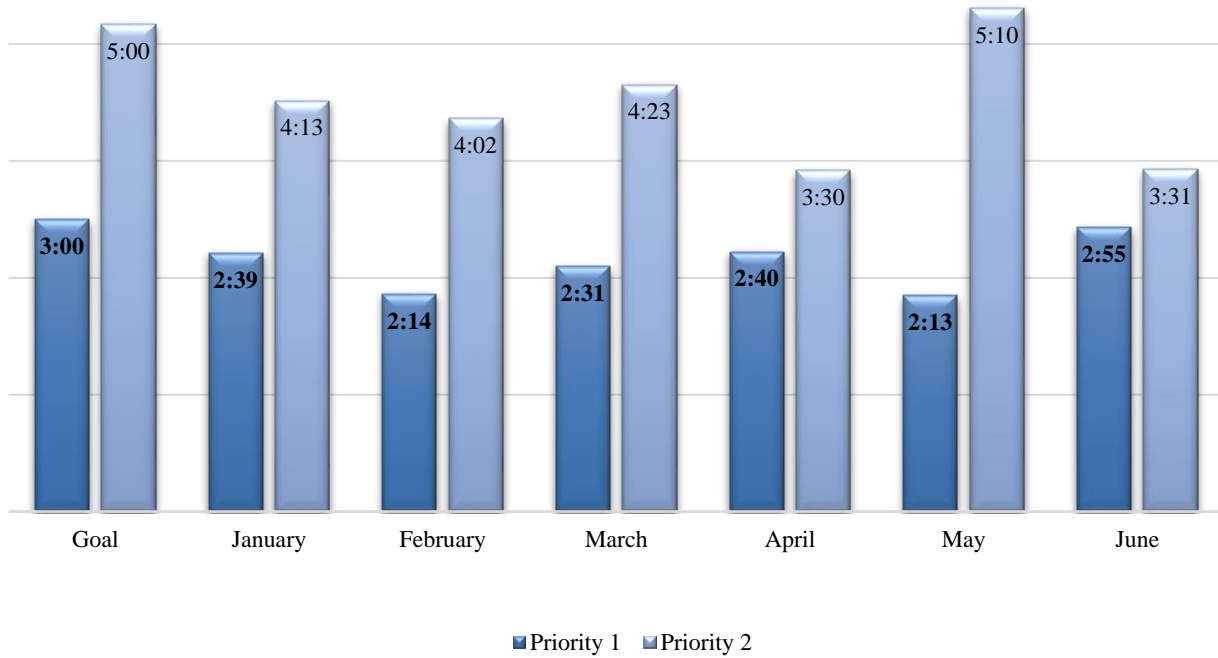

Response Times 2021



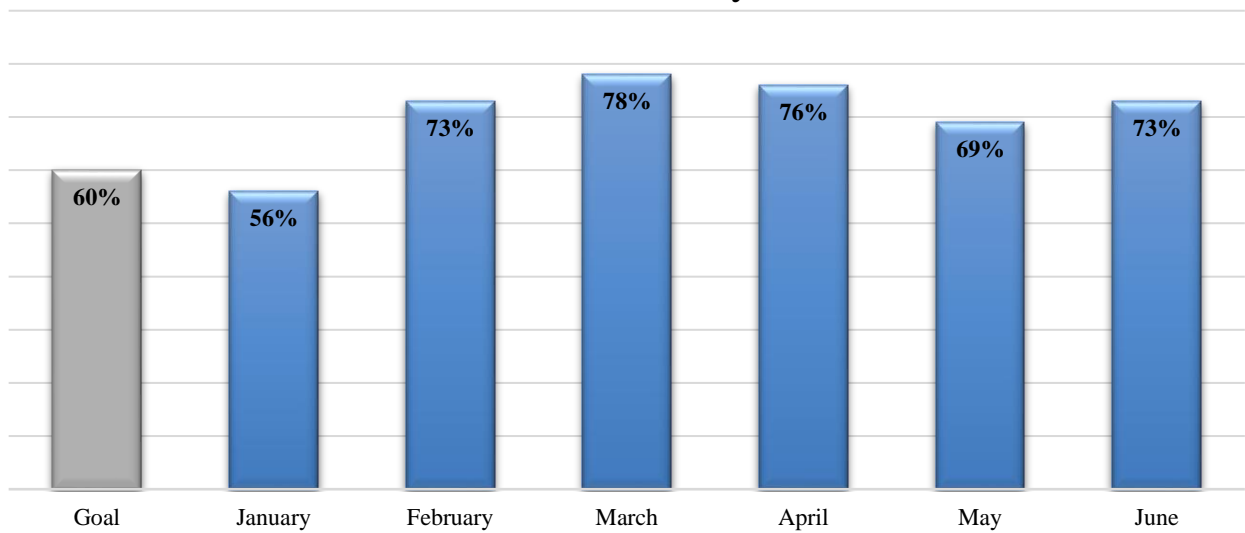

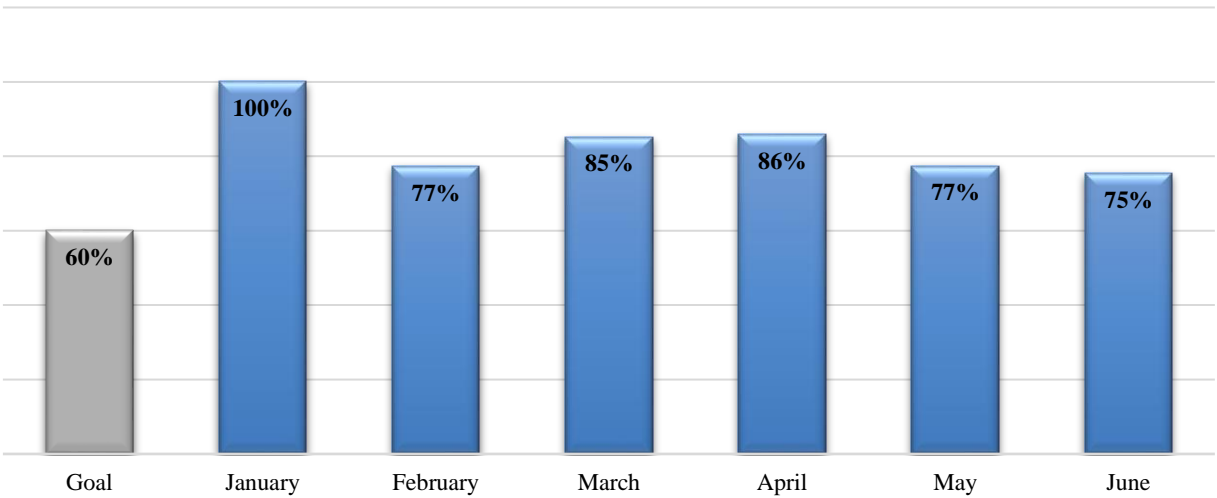

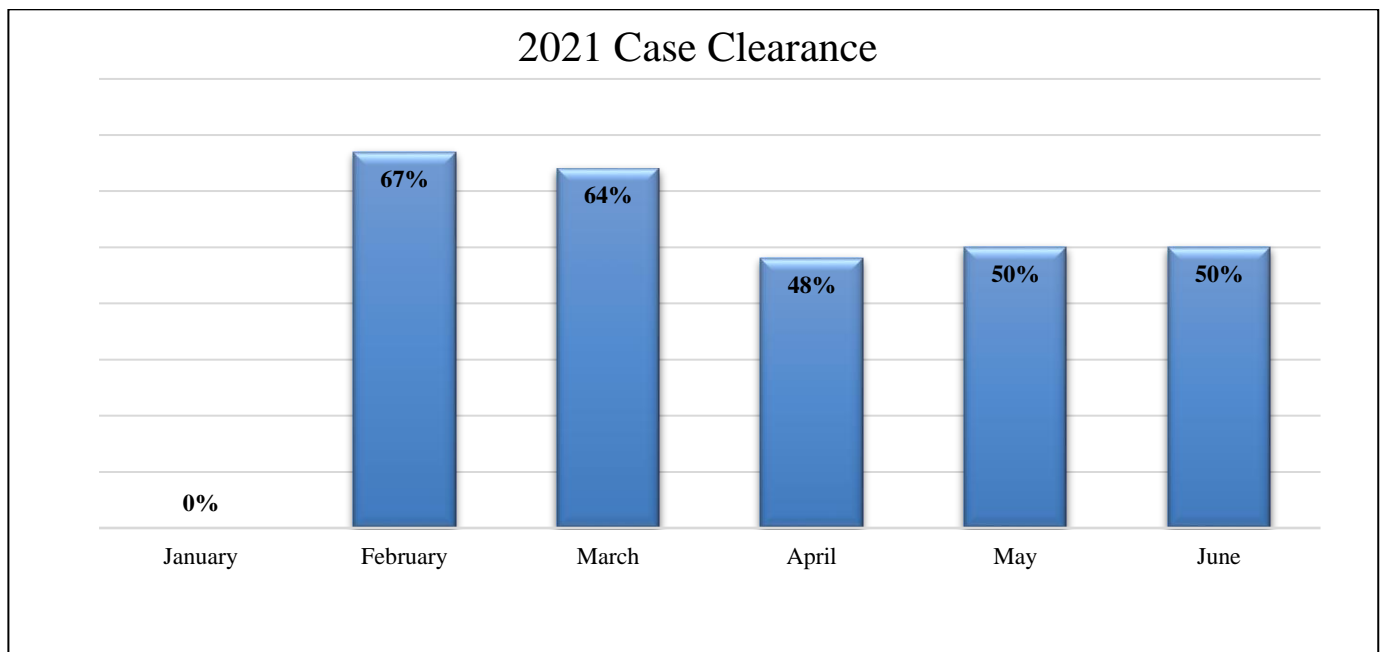

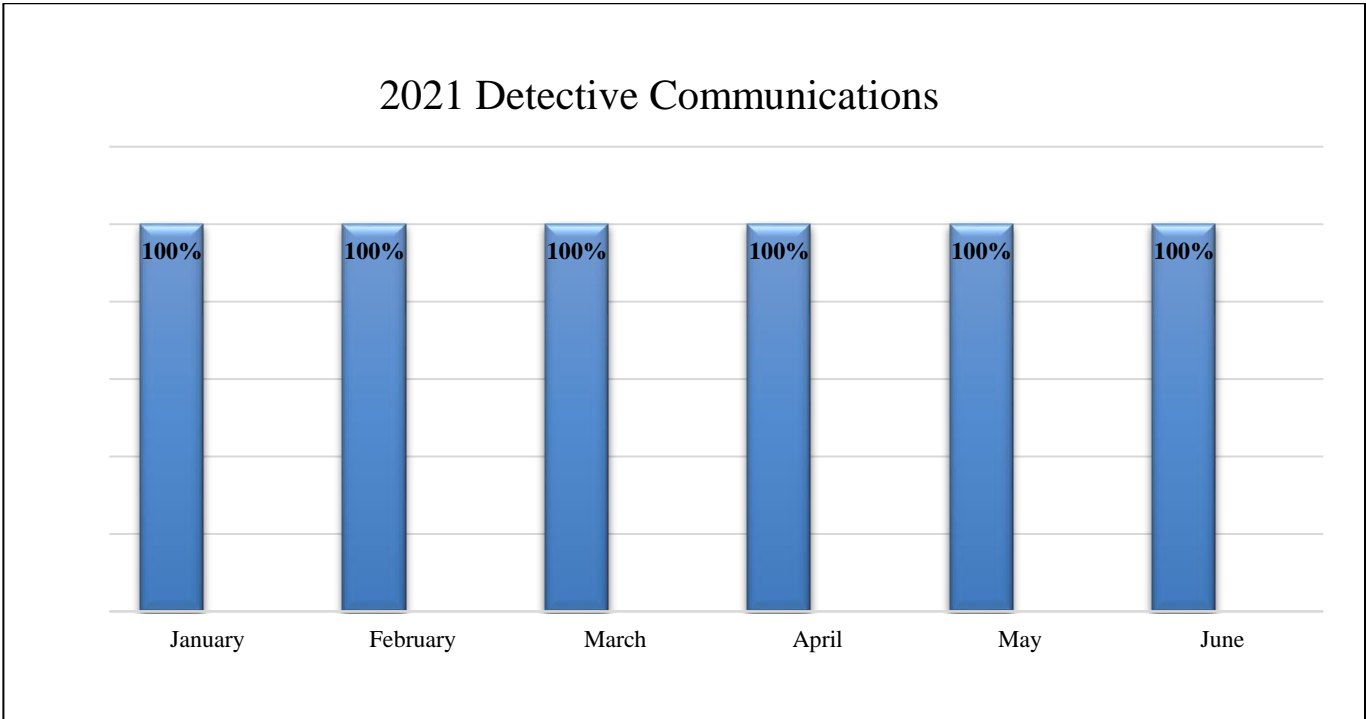
