CRIME DATA

In October of 2021, there were twenty two Part 1 crimes: five residential burglaries, two attempted residential burglaries, five thefts from motor vehicles, one theft of property, five thefts of motor vehicle parts, one theft of a motor vehicle, and three thefts of mail.

In three of the burglary cases, the suspect(s) smashed rear sliding glass door windows to gain entry into the residences. Once inside, the suspect(s) ransacked and removed the victim’s property and fled the location undetected.

In the fourth burglary case, the residence was under construction and the suspect(s) targeted a detached garage. The suspect(s) in this case pried open the locking mechanism securing the

garage door. Upon gaining entry, the suspect(s) removed the victim’s property and fled the location undetected.

In the fifth and final burglary, the victim in this case left their garage door partially opened. The suspect(s) gained entry in to the garage, and removed the victim’s property, and fled the location.

Of the attempted burglaries, in the first case, the suspect(s) attempted to gain entry into the residence through an unsecure window, however fled the area prior to gaining entry. In the second attempted burglary, the suspect(s) smashed a rear sliding glass door and fled the area prior to making entry.

The thefts from motor vehicles occurred from five unlocked vehicles where the suspect(s) gained access and removed the victims’ property. The suspect(s) fled the area undetected.

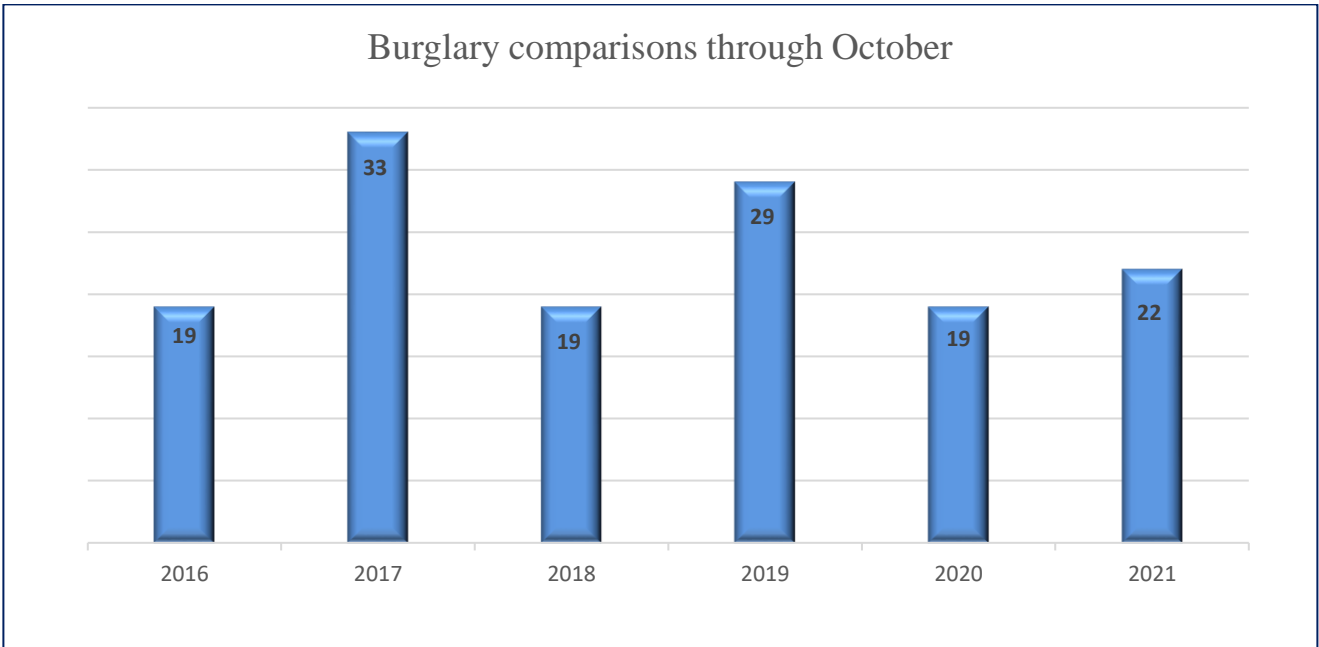
Of the property theft, the suspect(s) removed an electric bicycle from the driveway of the victim’s residence undetected.

The thefts of motor vehicle parts occurred from four parked vehicles. In the first two cases, the suspect(s) removed the vehicles’ catalytic converters and fled the area undetected. In the second two cases, the suspect(s) removed the vehicles’ rear license plates and fled the area undetected.

The theft of motor vehicle occurred when the owner of the vehicle parked their vehicle on the street directly in front of the residence. The suspect(s) gained entry in to the vehicle by unknown means, took the vehicle and fled the area undetected.

The thefts of mail occurred when the suspect(s) gained entry into secured mailboxes. In all three cases, the suspect(s) used force to gain entry and removed the victims’ property and fled the area undetected.

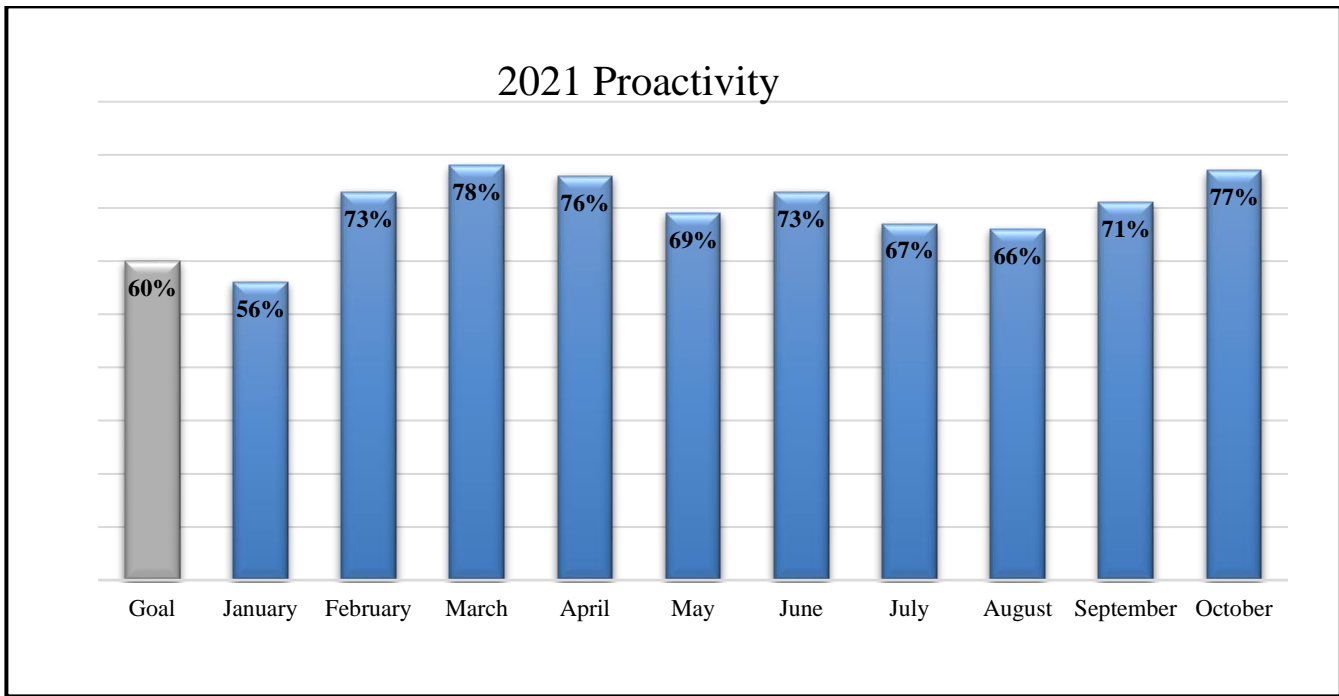

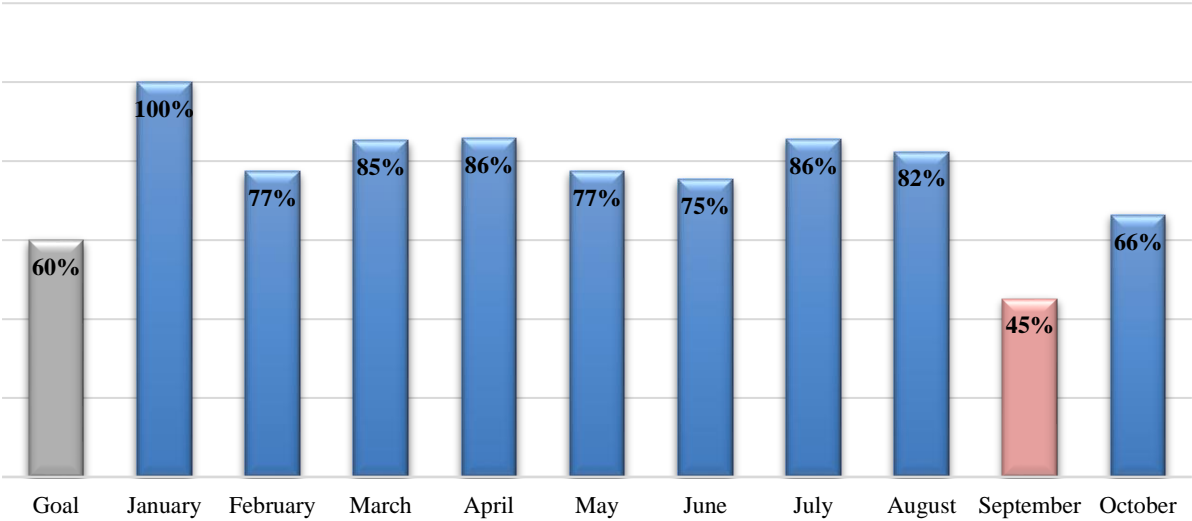

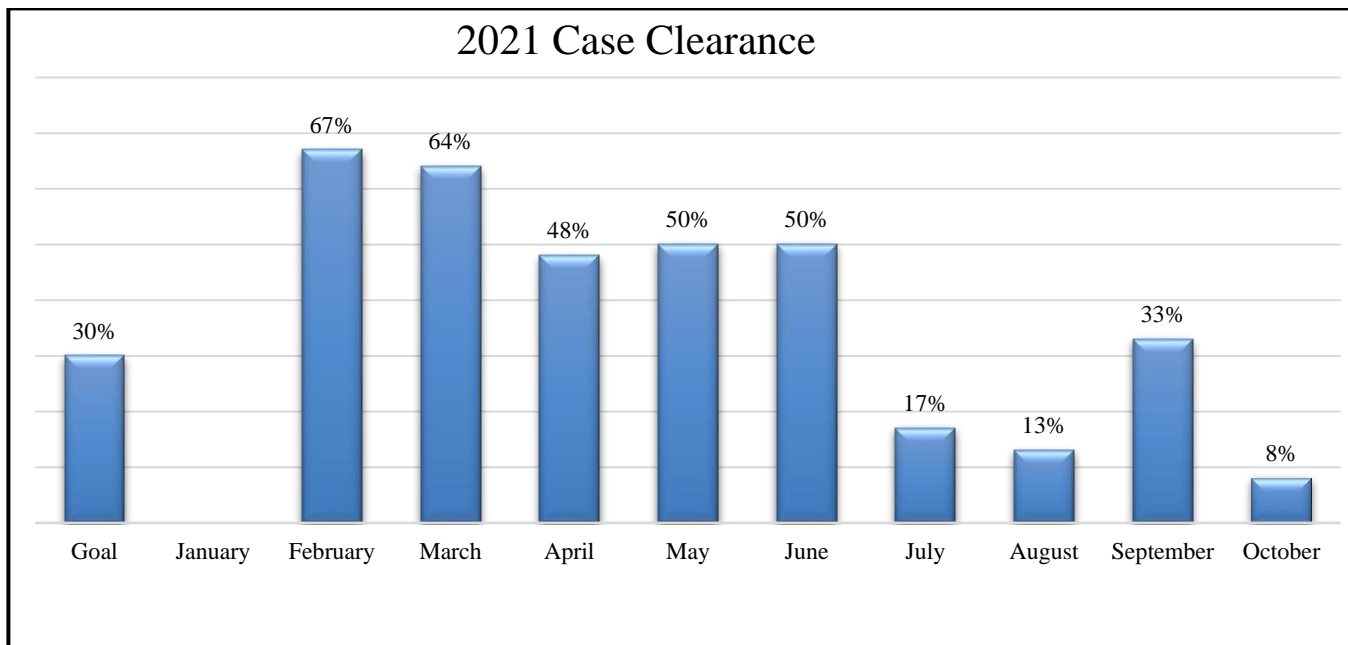

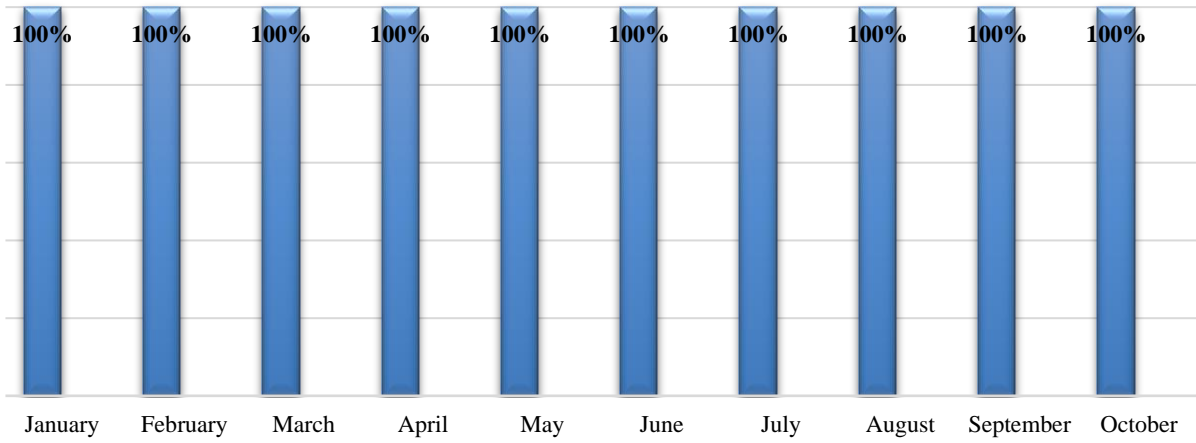
