CRIME DATA

In June of 2022, there were eight Part 1 crimes: 3 burglaries, and 5 larcenies (Thefts).

<u>Burglaries</u>: Unknown suspect(s) gained entry by smashing a rear sliding glass door with an unknown object. Upon gaining entry, suspect(s) ransacked the residence. Suspect(s) fled the location with victim's property in an unknown direction, undetected.

PVEPD Officers were alerted of a transient in the Valmonte area. PVEPD Officers arrived and observed the mentioned transient inside of a garage and remove the victim's property. PVEPD Officers subsequently contacted and arrested the suspect for burglary.

Unknown suspect(s) gained entry by prying open a rear sliding glass door with an unknown pry tool. Upon gaining entry, suspect(s) ransacked residence. Suspect(s) fled the area with victim's property undetected.

<u>Larcenies</u>: Unknown suspect(s) entered the victim's unlocked vehicle, removed victim's property and fled the area.

Unknown suspect(s) entered the victim's locked vehicle by unknown means and removed property. The suspect(s) fled the location with the stolen property.


Unknown suspect(s) entered the victim's locked vehicle by unknown means and removed property. The suspect(s) fled the location with the stolen property.






