The draft terms outline proposed regulations on La Venta Inn's event timing, frequency, and size; event site lot usage and residential neighborhood parking; outdoor activity; music and sound level monitoring; required communications submitted to the City and PVE residents; and compliance review process and ordinance enforcement.
