Maximum Event Size · Fire Code capacities to be followed at all times · Seated Dining - 135 plus staff · Cocktail - 200 plus staff

Event capacities should be per fire code. There is no reason to set a 2nd, conflicting standard

Event Frequency • Events of 75+ cannot occur more than 2 days in a row • One event per day except Saturdays during June. July. August which can have two events per day . No events on Thanksgiving, Christmas Eve. Christmas Day. New Year's Eve

These restrictions would be crippling to the business. La Venta's event business is a seasonal one. In the Summer months they need to book as many large events as is possible to offset the slow Fall & Winter months. This may include events of 75+ fri-sat-sun. And two events per day on Sundays.

The holiday prohibitions are without justification. No events New Years Eve? Really?

Timing - all events • 9 am to 9 pm Sunday-Thursday, indoor by 8:30 pm • 9 am to 10 pm Friday-Saturday, indoor by 8:30 pm • Clean up to be completed by 11 pm


