3-17-23 Scam Theft 2400 Block, Via Sonoma

On Wednesday, 2/15, unknown suspect(s) posed as an artist on Instagram and contacted victim via Instagram message—asking to use a photo the victim posted online for an art project. Suspect(s) sent victim a fraudulent electronic check in an amount greater than agreed upon. Suspects(s) then scammed the victim into sending money back via online cash app. The suspect's check was returned (bounced) and the victim lost the money sent.

3-27-23 Identify Theft 2100 Block, Palos Verdes Drive West

On Tuesday, 3/21/23, the victim noticed payments were made to AT&T and Geico Insurance, two services she doesn't have. Unkonwn suspect(s) gained access to victim's bank account and withdrew \$5K and made personal payments.

3-29-23 Identity Theft / Forgery 1500 Block, Paseo Del Mar

On 3/5/ or 3/6, the victim mailed a check for a large amount in the US Postal Mailbox in the 2500 Block of Via Tejon. On 3/28, he was notified by his bank that his check had been altered and deposited in Riverside County. We recommend always dropping off your checks with the US Postal clerks INSIDE the US Post Office.

3-31-23 Catalytic Converter (Grand Theft) 3400 Block, La Selva Place

On Friday, 3/17 at approximately 3 PM, the victim parked and secured her Honda vehicle. On Wednesday, 3/29 at approximately 7:30 AM, the victim started her vehicle and immediately noticed that it sounded different. Unknown suspect(s) removed victim's catalytic converter from vehicle and fled the location undetected.

3-30-23 Vandalism 100 Block, Rocky Point Road

Between Wednesday, 3/29 in the evening and Thursday, 3/30 at approximately 9 AM, unknown suspect(s) vandalized the victim's vehicle by etching profanities on the hood. The suspect(s) fled the area undetected.
