## ARREST

### **3-31-23                      Arrest – Impaired Driver                      300 Block, Palos Verdes Drive West**

At approximately 2:41 AM, an officer conducted a traffic stop. The investigation led to the arrest of the male driver for DUI.

At approximately 12:03 AM, an officer was dispatched to El Segundo PD, regarding a subject in custody for an open Want from PVEPD—as a result of good detective work by PVEPD officers. The suspect was transported to PVEPD Jail.

At approximately 12:27 AM, an officer conducted a traffic stop. The investigation led to the arrest of the female driver for DUI.

At approximately 3:01 AM, an officer conducted a traffic stop of a female driver and front female passenger. The investigation led to the arrest of the female driver for DUI.

### **4-6-23                      Arrest – Impaired Driver                      3000 Block, PV Drive West (South City Limits)**

At approximately 11:38 PM, an officer contacted a male driver who appeared to be asleep in the driver's seat—with keys in the ignition. The investigation led to the arrest of the male driver for DUI.

### **3-28-23                      Attempted Burglary Report                      4400 Block, Via Azalea**

At approximately 1:13 PM, two unknown suspects entered the rear yard of the residence and attempted to open a side door to the home. Suspects did not gain entry to the residence and fled the area undetected by unknown means. This incident was captured on the victim's Ring cameras. The suspect was identified from previous investigations.
