## **ARREST**

4-24-23 Arrest – Impaired Driver Via Del Puente

At approximately 11:27 PM, an officer conducted a traffic stop. The investigation led to the arrest of the male driver for DUI and an outstanding warrant.

4-26-23 Arrest – Drugs 600 Block, Palos Verdes Blvd

At approximately 3:15 AM, an officer conducted a traffic stop. The investigation led to the arrest of the male driver for possession of methamphetamine, possession of drug paraphernalia, and driving without an Ignition Interlock Device required for restricted license due to DUI conviction.

4-26-23 Arrest – Impaired Driver 1200 Block, PV Drive West / Douglas Cut

At approximately 10:15 PM, an officer conducted a traffic stop of a male driver and a female passenger. The investigation led to the arrest of the male driver for DUI.
