ARREST

5-16-23 Arrest – Drug Paraphernalia/Warrants Paseo De La Playa & Camino De Encano, Torrance
At approximately 1:33 PM, an officer conducted a traffic stop of a speeding vehicle. The investigation led to the arrest of the male driver for possession of drug paraphernalia, driving on a suspended driver's license and six

misdemeanor bench warrants.

Identity Theft 5-15-23

2600 Block, Via Pacheco

The victim received her bank statement via USPS and discovered an unauthorized withdrawal. She then contacted her bank. Unknown suspect(s) obtained access to the victim's bank account information by unknown means. Suspect(s) withdrew funds from victim's account.
