

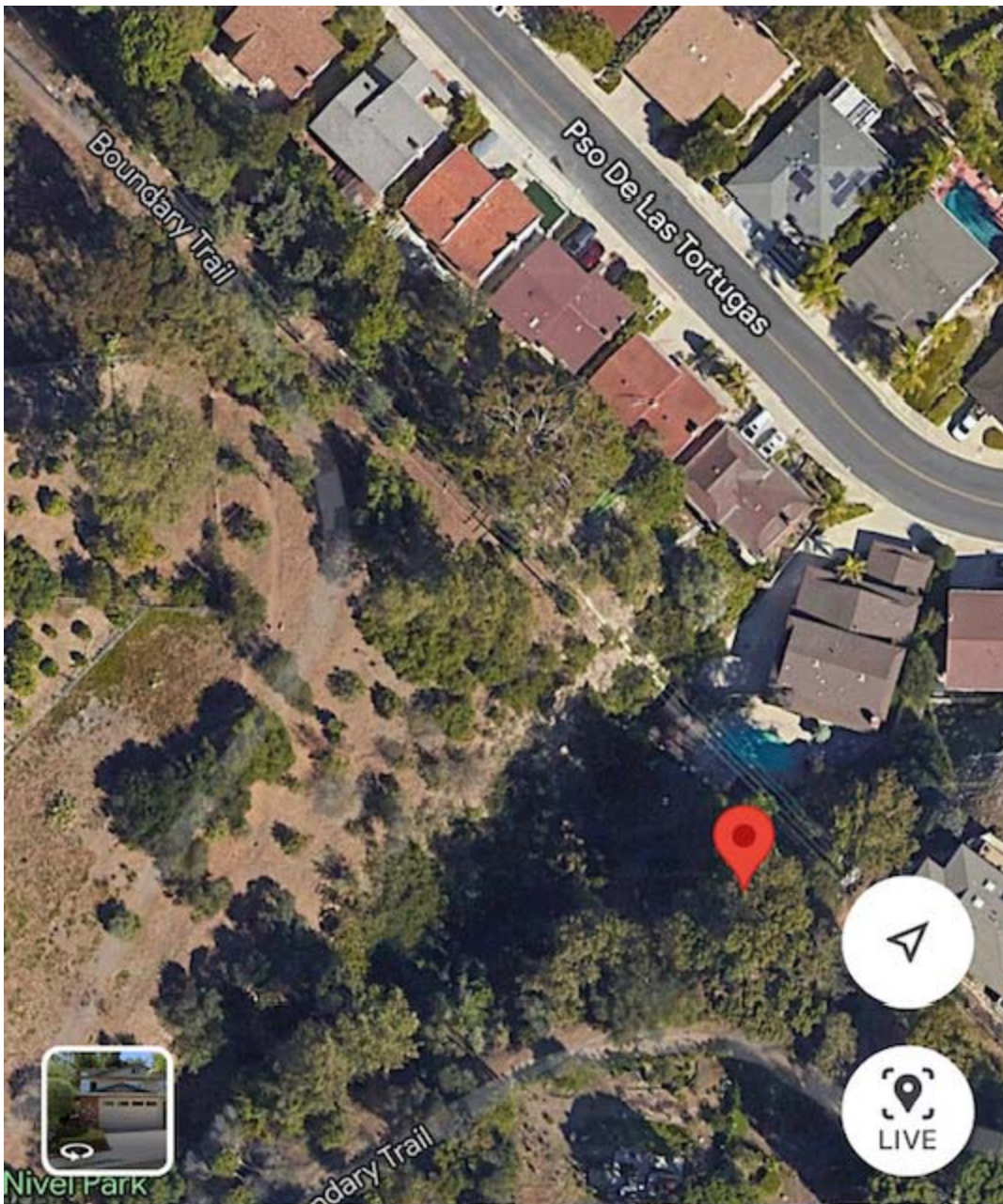

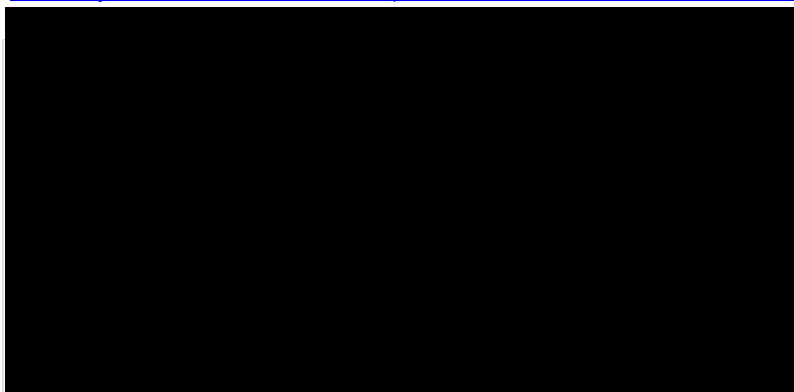
Highly desirable to be more specific regarding View - Main Viewing Area:

Currently there appears to be a disconnect between the Planning Commission, Parklands Committee and the Homes Association. It appears that the Planning Commission or the Parklands Committee does not review the Landscape Plans of a development.

Below is an excerpt from City of Malibu Primary View Determination:

- Primary view corridor” means a 180 degree view assessed by the Planning Director or designee from a single fixed location and direction within the main viewing area, at an elevation of five feet as measured from the room floor or on an abutting outdoor deck or patio at any one point within ten feet of the nearest outside wall of the structure as selected by the affected property owner and the City.
- “Primary living area” means the living room, family room, dining room, kitchen or a combination thereof.
- “Principal residence” and “Principal residential structure” mean the primary residential structure located on a lot. Guest houses, granny flats and second units are not principal residences or principal residential structures.

Thank you for publishing the draft policy for comment. We have lived in PV Estates for 11 years and have consistently struggled with overgrown trees in the neighborhoods. We are very supportive of having a consistent process for requests for tree trimming, rather than leaving it up to one individual who does not live in the neighborhood. That said, the policy seems to address on city trees, and we'd recommend that the policy cover private trees. We have a neighbor whose trees have grown into our view and refuses to address. We bought our home for the view and now we've lost 50% of it.
