NEW BUSINESS

REQUEST TO AMEND THE FY-2008 PALOS VERDES TENNIS CLUB CAPITAL BUDGET FOR MEN'S LOCKER ROOM PROJECT

Mayor Sherwood and Councilmember Rea disclosed that they are both members of the Tennis Club and have been advised by the City Attorney that there is no basis for conflict of interest on this matter.

Assistant City Manager Smith reported that the Tennis Club has requested an increase to a previously approved capital item for the 2008 fiscal year for the men's locker room renovation project. The project is currently budgeted at \$50,000 and the Club Board of Directors is asking to increase the budget to \$75,000 after receiving bids and updating the scope of the project. On July 29th Tennis Club Liaisons Councilmember Humphrey and Councilmember Rea met with Club representatives to discuss the project, the status of the capital fund, and future capital requirements. The 2008 capital budget currently totals \$85,500 including the \$50,000 for the locker room renovation project. The project is cosmetic in nature with no structural items involved. The Club has transferred \$25,000 of its undesignated operating balance and designated it for the capital fund which will assist in the financing of the project. The undesignated operating balance is now \$257,000 which is equal to 45% of the total operating budget.

Councilmember Goodhart stated that the City should be consistent with each of the Cities concessions with regards to capital improvements. He recalled that the Beach Club took a different approach with regards to capital improvements. Assistant City Manager Smith said that the City should look at each concession with regards to the circumstances especially since the initiation fees are much higher at the Beach Club than they are at the Tennis Club. There is also a much greater demand for membership at the Beach Club and they have resalable memberships.

Mayor Sherwood said he thinks it is a good idea to remove the carpeting in the men's locker room.

Councilmember Rea asked Tennis Club Manager John Hall to explain the water main break at the Club that occurred during the week. Mr. Hall explained that the break occurred under the walkway between a court and the Clubhouse. The main had broken and been repaired about 5 years ago. The Board decided to replace the remaining galvanized pipe with copper instead of again repairing it. The cost of replacement was \$15,000, and will be funded within the existing FY 2008 capital budget.

Mayor Sherwood asked Mr. Hall if \$75,000 would be enough to cover the cost of the locker room project. Mr. Hall said they received four construction bids and all are under \$75,000.

It was moved by Councilmember Humphrey, seconded by Councilmember Goodhart, and unanimously approved to amend the FY 2008 Palos Verdes Tennis Club capital budget in the amount of \$25,000 for the men's locker room project.

STAFF REPORTS

City Manager's Report

City Manager Hoefgen reported that the State Budget has finally been approved. There appears to be minor, if any, impacts to the City of Palos Verdes Estates. Cities with active redevelopment

agencies will see a loss of funds with this budget. The projects that the City has had on hold can now move forward including the Police Department locker room improvements and painting of City Hall.

DEMANDS

It was moved by Councilmember Goodhart and seconded by Councilmember Rea that the demands, as approved by a majority of the City Council, totaling \$232,090.10 be allowed and it was unanimously approved.

It was moved by Councilmember Goodhart and seconded by Councilmember Rea that the demands, as approved by a majority of the City Council, No. 514091V, 514109 to 514187 totaling \$1,055,300.32 be allowed and it was unanimously approved.

MAYOR & CITY COUNCILMEMBERS' REPORTS

Councilmember Rea reported that he attended the Traffic Safety Committee Meeting of September 10th and he was very impressed with the Committee's handling of a contentious meeting.

ADJOURNMENT

There being no further business before Council the meeting was adjourned at 7:55 p.m. to Tuesday, October 14, in the City Council Chambers of City Hall.
