This is a two-week recap of crimes.

ARRESTS

01-12-2024 Impaired Driver **100 BLK PVDW**

At approximately 4:22 AM, an officer conducted a traffic stop for Unsafe Stopping and Unsafe Turn. Upon contact with the driver, who exited the vehicle, the officer noticed a strong odor of an alcoholic beverage emitting from the person. The officer administered a test for horizontal gaze nystagmus (HGN) and the Standardized Field Sobriety Tests (SFSTs). Based on symptoms of intoxication, the driver was arrested for Driving Under the Influence of Alcohol.

01-13-2024 Impaired Driver **1300 BLK PVDW**

At approximately 12:33 AM, an officer observed two vehicles impeding traffic and failure to Maintain Lighting Equipment. After the officer contacted the driver of one vehicle, the driver was arrested for Driving under the Influence and Blood Alcohol Concentration of over .08%.

At approximately 11:43 PM, an officer contacted a subject walking the roadway on the center median on PVDN. The subject was subsequently arrested for Possession of Methamphetamine.

Upon contact with the driver, the officer observed an open bottle of "Fireball" and administered a test for horizontal gaze nystagmus and additional field sobriety tests (FST's). The driver was subsequently arrested for driving under the Influence of Alcohol and Drugs.

At approximately 11:35 PM, an officer observed a vehicle code violation and conducted a traffic stop. Upon completing a records check, a passenger was arrested for an outstanding warrant and Possession of a Controlled Substance.
