ARRESTS NOT ON PREVIOUS REPORT

03-25-2024 Mail Theft

800 BLK VIA SOMONTE

At approximately 5:48 PM, an officer was dispatched to a possible theft and arrested a subject for mail theft that occurred in January 2024.

THIS WEEK'S ARRESTS

03-27-2024 Traffic Offense

100 BLK PVDW

At approximately 12:01 AM, an officer observed a vehicle rolling through a stop sign and conducted a DMV records inquiry and it revealed Expired Registration and an Altered License Plate. The officer conducted a traffic stop and after receiving consent to search the vehicle located several mouse trap adhesive pads, a "fishing tool", and black adhesive tape, all of which is often used to create a tool to "fish" mail out of mailboxes. The driver and three passengers were arrested for Possession of Burglary Tools. One passenger was also charged with Providing False Identification to a Peace Officer.

04-02-2024 Warrant Arrest

At approximately 11:50 AM, an officer conducted a traffic stop on two motorized minibikes without rear-facing license plates and overtaking a vehicle by passing on the right. A warrant inquiry of the riders showed both had an outstanding warrants and both were arrested.
