ARRESTS

04-13-2024 Impaired Driver

2000 BLK PVDW

At approximately 1:55 AM, an officer observed a vehicle failing to stop, and then weaving inside the lane almost colliding with a raised concrete curb. The officer conducted a traffic stop, and upon detecting a strong odor of an alcoholic substance, conducted a series of Standard Field Sobriety Tests. Based on the subject's driving, objective symptoms of intoxication, and performance of the SFSTs, the Driver was placed under arrest for Driving Under the Influence and Child Endangerment, having two children in the vehicle.

Between 04-05-24 at approximately 9:00AM, and today's date, the victim called an unknown suspect who listed their phone number as a technological support company. Suspect gained access to Victim's computer by unknown means and scammed Victim into thinking Suspect sent money to Victim. Suspect arrived at Victim's residence and Victim hands Suspect \$14,000 cash under false pretense.
