ARRESTS

06-19-2024 Weapon Violation VIA VALMONTE & PVDN

At approximately 3:30 PM, an officer conducted a traffic stop for observed vehicle code violations. During a search, the driver was found to be in possession of a loaded unregistered handgun and arrested.

06-20-2024 Suspicion of Vehicle Burglary 300 BLK PVDW

At approximately 11:40 AM, officers responded to a report of a man acting suspiciously and checking car door handles of parked vehicles in the 600 block of Paseo Del Mar. Officers contacted a man matching the description but were unable to substantiate a crime, and he was released. Detectives conducted surveillance on the man and later conducted a traffic stop as he departed the area. During a search of the vehicle, detectives located burglary tools, drug paraphernalia and an illegal billy club. The driver was arrested for possession of burglary tools, possession of a billy club (dangerous weapon felony), and suspicion of burglary. The passenger was arrested for an outstanding arrest warrant, possession of drug paraphernalia and suspicion of burglary.

CRIMES NOT ON LAST WEEK'S REPORT

06-18-2024 Warrant Arrest VIA VALMONTE & PVDN

At approximately 10:00 AM, an officer conducted a traffic stop for an observed vehicle code violation and arrested the driver for an outstanding arrest warrant.

THIS WEEK'S CRIMES

06-21-2024 Prowler Seen 3300 BLK VIA LA SELVA

At approximately 10:00 PM, unknown suspects gained access to the rear of the residence by prying open the locked side gate. After the suspects heard the resident was home, they fled the location without attempting to make entry to the residence.

06-22-2024 Weapon Violation 1200 BLK PVDW

At approximately 1:50 AM, an officer conducted a check on a parked vehicle. After contacting the driver, the officer observed an open container and, during a pat search, located a butterfly knife in the subject's front pants pocket. After searching the vehicle, officers located firecrackers and artillery shells fireworks. The driver was arrested for possession of dangerous fireworks. The driver was cited for having an open container, a passenger was cited for possession of a butterfly knife, and another passenger was cited for dangerous fireworks.

06-22-2024 Pursuit 3800 BLK PVDN

At approximately 3:10 AM, an officer attempted a traffic stop for an observed vehicle code violation. The officer attempted a traffic stop and the driver fled. A short vehicle pursuit ensued but was terminated by police for safety reasons.
