## **ARRESTS**

#### 09-07-2024 Drugs

#### **300 BLK PALOS VERDES DR W**

At approximately 12:24 AM, an officer observed a vehicle code violation and conducted a traffic stop. During the traffic stop, a second officer observed an open bottle of Fireball whiskey. After receiving consent to search the vehicle, officers located several cylinders of compressed gas and arrested the driver for possession of nitrous oxide and driving without a license.

## 09-11-2024 Drugs & Warrant Arrest

At approximately 12:20 AM, an officer observed a vehicle with several vehicle code violations and conducted a traffic stop. A records check indicated the driver had two outstanding warrants and required an ignition interlock device. At approximately 7:48 PM, a minor traffic collision occurred near the intersection of Via Anita and Palos Verdes Dive West. The passenger of the vehicle at fault, a white sedan, checked on the driver of the other vehicle and confirmed there were no injuries. The passenger stated all parties would exchange information; however, after the passenger returned to the white sedan, it fled the area eastbound on Palos Verdes Drive North. No injuries were sustained.
