#### ARRESTS

**10-16-2024 Traffic Offense 100 BLK PALOS VERDES DR W**

At approximately 11:50 PM, an officer observed a vehicle code violation and during the traffic stop observed an open alcoholic beverage container and the driver required to have an Ignition Interlock Device (IID) installed. The driver was arrested for driving on a suspended driver's license for DUI and Ignition Interlock Device required.

**10-18-2024 Hit and Run/DUI 1100 BLK PALOS VERDES DR W**

At approximately 5:20 PM, an officer observed a vehicle strike a bicyclist after making a U-Turn. The officer conducted a traffic stop, and upon detecting an unknown alcoholic beverage emitting from the vehicle, arrested the sole occupant for Driving Under the Influence of Alcohol.

At approximately 2:11 AM, an officer observed a vehicle code violation and conducted a traffic stop.
