HOLIDAY SAFETY

Accidents can happen. Here are some quick and easy tips to help keep you and your loved ones safe this holiday season:

AT HOME

- Don't overload electrical circuits.
- Make sure decorations are not blocking doors and passageways.
- If you have a fireplace, woodstove, or use gas logs/furnace, be sure you have an operable UL approved carbon monoxide detector.
- Keep candles, Yule logs and Menorahs away from drapes, trees or other flammable objects.
- Extinguish all candles before leaving home or going to sleep.
- If you have a Christmas tree, be sure it is mounted on a sturdy base that cannot be easily tipped.
- If you have a real, live Christmas tree, place it in water or wet sand to keep it green. If the tree is an artificial tree, make sure it is flame resistant.
- Never place wrapping paper in, or near, your fireplace.
- Keep large displays and holiday gifts out of view through windows and doors.
- When someone comes to your door, don't be afraid to ask questions and request identification.
 Sometimes criminals will pose as couriers delivering gifts. It's also not uncommon for people to go door-to-door and ask for charitable donations when there is no charity involved.

IN THE CAR

- Always wear a seatbelt and use child safety seats.
- Get a good night's sleep before starting on the road for a long drive.
- Never get behind the wheel after drinking alcohol.
- Avoid driving alone, or at night. If driving at night, park in a well-lighted area.
- Keep all doors locked and windows closed while in or out of your car.

- Do not leave packages or valuables in plain view in your car.

Rainy Season Preparation

As we endure the water drought and welcome precipitation during the upcoming rainy season, it is also important to takes steps to avoid unintended consequences of water. Please be prepared as the rainy season approaches by following these guidelines:



- Keep trees trimmed to reduce foliage.
- Clean rain gutters, swales and drainage pipes on your private property.
- Inspect roofs, gutters, window caulking and insulation, and repair if needed.
- In case of electrical failure, be sure to keep large flashlights and extra batteries on hand and keep utility contact numbers close by.

To help alleviate flooding when heavy rains occur, consider obtaining sandbags that can be purchased at any home improvement store. Empty sandbags are also available 24/7 in front of the Police Department, with sand available on the empty lot, just west of the Fire Department.

Mindful of the drought, please also turn-off irrigation sprinklers when it rains and consider utilizing rain barrels for the collection of irrigation water.

Business License Renewals Due January 1, 2015

Business licenses are required for anyone doing business in the City of Palos Verdes Estates. Annual business licenses will expire December 31, 2014. Please renew your business license by January 31, 2015 to remain in compliance with the municipal code and to avoid late penalties. If you are currently licensed, you will receive a renewal notice by mail in mid-December 2014. If you do not receive a license renewal, or are a new business, please contact or visit the City's Finance Department at City Hall, or call (310) 378-0383. New applicants must complete an application which is available on-line on the City's web site.

Renewal forms should be mailed to, or returned at, City Hall. All pertinent information on the renewal form must be fully completed and include a signature of an authorized representative of the business.

In 1993, Council authorized home occupation businesses under certain limited conditions. If you operate any business from your home, you need to secure a home occupation business license.

FIRE & PARAMEDIC SERVICES



On March 6, 2007, by over a twothirds majority, voters approved the City of Palos Verdes Estates Fire and Paramedic Services Special Tax -

a parcel tax for 10-years based on the size of properties (not the assessed value) to cover the costs of the paramedic and fire services provided within Palos Verdes Estates by the Los Angeles County Fire Department (LA County). This important annual revenue source is nearly \$4.5 million, to provide by contract, emergency medical and fire response.



Paramedic and fire services are integral to the quality of life and safety in Palos Verdes Estates. Although Fire Station 2 at City

Hall (340 Palos Verdes Drive West) is our main station, emergency services are additionally received from other stations on the Peninsula, as needed, depending on the location and size of the incident. The second primary station is Fire Station 106 located at 27413 Indian Peak Road.

Residents are always welcome to visit Fire Station 2 for tours and to see the equipment. Some important service statistics of interest include:

- Fire Station 2 includes a 3-Person Engine and 2-Person Paramedic Squad.
- Fire Station 106 includes a 4-Person Quint (truck w/water pump), 3-Person Engine

and 2-Person Paramedic Squad.

- Emergency Medical (Paramedic) calls annually total approximately 525 or 76% of all calls.
- The Fire & Paramedic Department coordinates closely with the Palos Verdes Estates Police Department and plays a central role in emergency preparedness and disaster recovery planning.
- The LA County contract benefits the City from economies of scale gained as being part of a wider regional fire district that can share resources as, and when, needed.
- Fire services play an important role in coordination of proactive fire prevention services.



For the past twenty (20) years, the City's paramedic and fire services contract with LA County has been solely funded through a voter approved

Special Parcel Tax. The tax is, and has been, applied to both residential and commercial properties and supports a core municipal and safety service that has no alternative funding source. Because paramedic and fire services is 40% of the City's General operating costs, the underlying tax revenue source is essential to community's quality of life and safety. In past elections, voters approved the tax with over 80% support - a margin that exceeds the 2/3 voter requirement. The parcel tax will be scheduled for renewal by a vote of residents in March, 2017.

Fire & Weed Abatement



Years of drought and overgrown vegetation in the City's parkland areas creates a challenge relative to fire safety. The dry and dense condition of vegetation that is close to homes in

the parklands ignites concerns, and can inhibit the Fire Department's ability, for fighting and controlling fires and minimizing damage to structures.

Like the other cities on the peninsula, Palos Verdes Estates is located in a Very High Fire Hazard Severity Zone (VHFHSZ) due to the wildland-urban interface where the backyards of homes abut dense stands of native-naturalized vegetation in canyons and open space areas. In turn, brush management is needed annually to reduce fire hazards around structures.

Concurrently, the City also has a responsibility to protect sensitive biological resources. Brush management activity must therefore be accomplished in a manner that both reduces fire hazards and minimizes impacts to undisturbed native or naturalized vegetation.

This year, and consistent with the Fire Department's requirements, the City has significantly increased defensible space in the parklands around homes through its annual brush clearance program by clearing brush, trimming low hanging branches and removing dead trees and vegetation. Community residents, the Los Angeles County Fire Department and the Los Angeles County Agriculture Department have noticed the difference and expressed their appreciation for the improved fire safety measures.

Going forward, the City plans to provide greater fire protection by supplementing the annual brush clearance program with additional efforts in 2015 and 2016. In future years, the program will further improve fire safety and defensible space by clearing weeds and brush in more remote locations in parklands. A byproduct of the brush clearance efforts will also be an improved sense of openness through the City's parklands.

BICYCLE SAFETY ZONE LAW IN EFFECT



A "Three Feet for Safety Act" took effect, that requires drivers to give bicyclists, traveling in the same direction, three feet of clearance when passing. This new law improves safety by giving bicyclists more space on the road. According to the new law, if traffic or roadway conditions prevent motorists from giving bicyclists three feet of space before passing, drivers must slow to a speed that is reasonable and prudent and only pass when three feet of clearance is available. Please drive safely.

Written communication can be sent via email to cityclerk@pvestates.org or by mail to City Hall. When you wish to address an item that appears on any meeting agenda, transmit your correspondence to the City by the close of business on the Thursday preceding each meeting. This correspondence will be

included with the public materials that are prepared for review and consideration of the item. Correspondence received after publishing the meeting materials will also be distributed at the meeting; however, in that it was not included with the published materials for the public, it will be stamped "not reviewed."

"Communications from the Public" is another effective means of sharing information and opinions at City Council, Planning Commission, Traffic Safety and Parklands Committee meetings. Under this heading on meeting agendas, the public may address the Council, Commission or Committee on any topic of interest that is not on the posted agenda. Although no action can take place at the meeting, the topic may be placed on a future agenda for consideration. Also, the public may verbally comment on any item listed on the agenda at the time it is discussed. Every member of the public is provided up to three minutes to verbally share their viewpoint.

SCE Outage App Now Available_





residents, telling a friend "I'm in the dark" has literally meant that the power was out. The lights were off because

California Edison (SCE) Southern electricity had stopped working. SCE tracks outages with three metrics: the System Average Interruption Duration Index (SAIDI), the System Average Interruption Frequency Index (SAIFI), and Average Frequency of Momentary Interruptions (MAIFI). SAIDI measures the amount of time the average SCE customer was without power for more than five minutes (called a "sustained outage") in a given year. SAIFI is the number of times the average SCE customer experienced a sustained outage in a given year. According to SCE's own metrics https://www. sce.com/nrc/reliability/reports/ palosverdes.pdf, Palos Verdes Estates outages in all three categories reached a peak in 2011, and outages in the City well exceeded SCE's system-wide averages. The reason? A 40-year old and unreliable infrastructure that necessitates replacement.

Following the City Council strongly and repeatedly expressing its complaints to SCE, City representatives joining with other South Bay cities in meetings with the Public Utilities Commission (PUC) and SCE officials, and an increasing number of residents voicing their

dissatisfaction with the reliability of power, SCE commenced with capital improvements to their infrastructure. In calendar year 2014, as the fourth year in a ten-year multimillion dollar plan for the entire Palos Verdes Peninsula, SCE will have spent approximately \$635,000 infrastructure in improvements specifically in Palos Verdes Estates. Over the past four years, SCE has replaced more than 400 utility poles, 78 miles of underground cable and other work, according to Marvin Jackmon, SCE spokesperson. Concurrently, SCE has initiated new and better communications systems to notify residents of scheduled and unscheduled outages. One improvement is a SCE "app" for smart mobile telephones. The app, available at www.sce.com/mobileoutage, provides the public with a simple means of reporting outages and an interactive map to clearly see where outages are occurring.

Although all the reliability and notification problems encountered by residents are not completely resolved, great strides have been made toward addressing both, and the City has been assured more is planned. City and SCE officials continue to meet to discuss necessary improvements to the timing and notification of outages and about improvements to the reliability of power. Residents are encouraged, in the meantime, to download the SCE app to stay informed of outages as they occur.


