COMMUNICATIONS FROM THE PUBLIC

Niki Tennant, representing Assembly Member Bonnie Lowenthal, provided an update on activities of the office, including legislation authored by the Assembly Member and signed by the Governor. She also repeated grim warnings on the fiscal status of the State and dire consequences of the anticipated \$21 billion budget shortfall.

PUBLIC HEARINGS

JANUARY 26, 2010 CITY COUNCIL RESOLUTION R10-01; A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, ADOPTING A REVISED FEE SCHEDULE FOR SERVICES RENDERED RELATING TO BUILDING AND SAFETY, PLANNING AND PUBLIC WORKS PERMITS

Assistant City Manager Smith reported that the City is permitted to recover the cost of providing development services to ensure that the party requesting the services pays for the cost of these services and not the general taxpayer. The methodology for evaluating these costs includes direct and indirect cost components over a three year period. This year's evaluation indicated an 18.4% increase in fees is warranted. This year Planning related fees were looked at more closely due to an increasing shortfall in this area. The evaluation showed PVE's fees ranged from 22% to 66% lower than the other surveyed cities. Staff recommended a 20% increase in Planning fees and a 10% increase in Building fees. She noted that the 20% increase ranges from \$17 to \$265 for the most There is a newly proposed fee classification related to Revised common applications. Neighborhood Compatibility Applications. Once a property has been through Neighborhood Compatibility (NC), any future changes or additions to the property are also subject to a Neighborhood Compatibility Review. Currently, these applications pay half fees regardless of when the original approval was processed. Staff proposed that once the original construction associated with the NC approval is finaled, that any revised application would be subject to full fees.

Councilmember Rea asked why the costs had increased. Director Rigg responded that the increases are typically 2%-3% per year and there has not been a fee increase since 2006.

Councilmember Rea asked if the City tracked the number of Neighborhood Compatibility applications that are approved the first time around, second time around, etc. He said that every time a NC application goes before the Planning Commission there is staff time involved to work the application. Director Rigg said that each subsequent time an application goes before the Commission it is essentially free of charge, but it would be difficult to determine exactly what the additional costs are. Also, it may put applicants in a difficult position to accept a continuance if there was going to be an additional fee charged.

No members of the public wished to speak on the matter.

After Council discussion, it was moved by Mayor Pro Tem Humphrey, seconded by Councilmember Goodhart, and unanimously approved to adopt Resolution R10-01 to adopt a revised fee schedule for development services, which reflects a 20% increase in planning application fees and a 10% increase in building and public works permit fees.

Mayor Perkins attended the Re-Opening and Dedication of the PVPUSD Malaga Cove Administration Center earlier in the day along with Mayor Pro Tem Humphrey, Councilmember Goodhart, Councilmember Bird and City Manager Hoefgen. She said it is a beautiful facility and great addition to the City of PVE. She also spoke at the Breakfast Club on the State of the City where she was asked about the traffic in Malaga Cove in the afternoons. She would like the Council to look into the situation. She, along with Councilmember Goodhart and City Manager Hoefgen, attend the SBCCOG workshop on regional agencies.

Mayor Pro Tem Humphrey will be attending the City Selection Committee Meeting on February 4th and she asked for the Council's concurrence to nominate and cast the City's vote for Judy Mitchell as representative to the Air Quality Management District.

Councilmember Bird mentioned that the Malaga Cove Homeowners' Association is fundraising to help the school district landscape the new MC Administration Center.

Councilmember Goodhart reported on his attendance at the League of California Cities policy committee meetings for Public Safety and Environmental Quality held in Sacramento February 20-22. Copies of his notes from the meeting will be distributed to the City Council.
