Tree removal for all residents of Palos Verdes Estates

on normal pickup days from Monday, December 27, 2010 through Friday, January 7, 2011. Place your whole tree in your trash barrel storage area. Be sure to remove stands and decorations such as tinsel and ornaments. Lightly flocked trees are acceptable. For removals after January 7th, trees that are more than 4 feet in height will need to be cut in half; cut and bundle your tree securely with twine or rope and place it in your trash barrel storage area for removal. Ham Radio Operators Still Needed

uring times of disaster, the systems that are relied upon for everyday communication (landline phones, cell phones, the Internet, etc.) will likely be damaged and disrupted – making it more difficult for the City to be aware of conditions in your neighborhood. To overcome this communication challenge, the PVE Police Department has partnered with the Neighborhood Amateur Radio Team (NART) to recruit and retain local residents to volunteer as ham radio operators.

The Neighborhood Amateur Radio Team is a vital element in the City's disaster preparation efforts. While NART's ranks have grown to 27 skilled and licensed ham radio operators within the City, there is a need for a total of 50 licensed operators. We are

half way there, and with your help, we will reach our goal of 50 NART members!

How can you become a licensed ham radio **operator?** It's easy! A basic ham license requires minimal technical experience; NO Morse Code knowledge is needed. Free training is readily available and only requires approximately eight hours at a given time. It is a great way to serve your community and to increase your overall awareness of the City's disaster preparedness plan. Business License Renewals Due Soon

usiness licenses are required for any business conducted in the City. In order to avoid late penalties, please renew your business licenses no later than January 31, 2011. All existing businesses should receive a license renewal form in the mail during the month of December. If you do not receive it, or are a new business within the City, please contact the City's Finance Department at (310) 378-0383, or visit the City website, www.pvestates.org under the "I Want To..." section to find the form.

Please note, home occupation businesses are only allowed under certain conditions. Individuals with a home business will need to secure a home occupation permit for 2011. If your business is solely operated from a location outside of the city, you should use that location's address for any state licenses or correspondence so you are not subject to a City business license as well.

Should you require additional information, or have any questions, please contact the Finance Department.

Building and Safety/Planning Departments

he City's review of private development is coordinated through the City's Building and Safety and Planning Departments. These departments are comprised of a full-time Building Official, a part-time Building Inspector, a full-time and a part-time Permit Technician, a Planner, and the Planning Director. The Planning Director also serves as the City's Public Works Director, which allows him to have a broader view of the issues facing the City. These employees are responsible for making sure that construction within the City complies with all applicable local and state regulations.

The Building Department implements the California Building Codes through the review and inspection of construction on private property within the City. The Department helps ensure that private development complies with pertinent codes and regulations through diligent inspections, plan check reviews, and attentive project management. Upcoming challenges will be to implement the new California Green Building Code and the latest regulations requiring sprinklers in new homes. Both of these regulations will become effective January 1, 2011.

The bulk of planning work includes the review of applications for the Planning Commission process, most notably the Neighborhood Compatibility application. Staff reviews the plans, verifies that the design complies with the Municipal Code, and prepares a report for Planning Commission review. Recently, the Planning Department has additionally been reviewing new Wireless Telecommunication Facilities applications as these companies request extra sites.

The Building and Safety/Planning Departments are critical to ensuring that construction in the City is safe and allowable per our carefully crafted regulations. These Departments are constantly evaluating processes to improve their effectiveness and to meet ever-changing State mandates.

South Bay Environmental Services Center: Whole House Energy Efficiency

looks at the entire house
as an interconnected,

interactive energy system. For instance, the benefits of an energy efficient heater are lessened when a duct system leaks, windows don't close tightly, attic insulation is insufficient, and cool ocean breezes drift in under the door.

This approach recognizes the interaction of windows, attics, foundations, mechanical equipment, and all other components within the home. Modifications in one or more components can cause changes in how other components perform.

Why is this approach important? The benefits of the whole house approach include better diagnostics of energy problems, reduced utility and maintenance costs, increased comfort, and it helps the environment. Energy efficiency not only saves you money, it also saves natural resources. Generating electricity for your home typically uses nonrenewable resources, such as coal, natural gas, and oil, which also impacts the environment. Energy efficiency helps reduce the negative effects of burning fossil fuels by providing the same quality of services

with reduced energy inputs and emissions.

Water is also a big part of this equation. It takes water to process fuels to generate electricity and, in turn, it takes energy to distribute and treat water.

There is exciting news on the horizon that will assist homeowners achieve energy efficiency in their home, using the whole-house approach. The Energy Upgrade California in Los Angeles County, with incentives of up to \$4,000, will soon be available to homeowners with detached single-family homes who complete qualifying energy-saving home upgrade projects. 
