The Issue

Shall the City Council adopt Resolution R10-29 to appoint the persons nominated for Member of the City Council (3) and cancel the election previously scheduled to be held Tuesday, March 8, 2011?

Analysis and Findings

On October 12, 2010 at a regular City Council meeting, the Council adopted Resolution R10-20 calling for an election to be held in the City on Tuesday, March 8, 2011. A notice announcing that the City would conduct an election on Tuesday March 8, 2011 was posted on October 21st and published in the Peninsula News on October 21st and published in the Chinese Daily News on October 24, 2010 in accordance with provisions of the Election Code. Prior to these actions, the City announced in the October issue of the City newsletter, which is delivered to each home and business in the City, that the City would hold an election and provided information on the nomination period and how nomination papers could be obtained.

The nomination period for the March 8, 2011 election began Monday, November 15, 2010. As of the close of the nomination period on Friday, December 10, 2010, the number of persons nominated by qualified electors of the City was equal to the number of offices available. The persons nominated are:

Member of the City Council

Rosemary Humphrey Ellen Perkins John Rea

As required by Election Code Section 10299, the City posted and published a notice that there were not more candidates than offices to be elected and that the City Council would meet on Tuesday, December 21, 2010 to consider the options available to them.

In the current circumstances, where the number of candidates nominated is equal to the number of offices available, the applicable options available to the Council under the Election Code are to

CITY COUNCIL AGENDA DECEMBER 21, 2010 appoint those nominated and cancel the election by adopting the attached resolution OR to order that the election be held as scheduled.

There is significant expense in conducting an election. The City had budgeted \$27,500 to conduct the March 2011 election. The net cost to the City would have been less than that amount due to the fact the City of Los Angeles would have shared in part of eligible expenses since the Council agreed to consolidate our election with the City's election of members of the Community College District Board. The Notice of Insufficient Candidates has been provided to the City of Los Angeles and they will conduct their own election within Palos Verdes Estates, if the March 8, 2011 General Municipal election is canceled.

If the City Council adopts Resolution R10-29, the persons appointed will serve as if elected. The persons appointed will assume office in March, 2011 and the City Council will reorganize at that time.

Alternatives Available to the City Council

- 1. Adopt Resolution R10-29.
- 2. Decline to adopt the Resolution and order that the election be held.

Recommendation

It is recommended that the City Council adopt Resolution R10-29 appointing to the office the persons nominated for Member of the City Council (3) and cancel the election scheduled to be held Tuesday, March 8, 2011.

Fiscal Impact

The recommendation to cancel the election is provided to the Council because the cost to conduct an election, when none is required due to the number of candidates nominated, would result in an unnecessary expense to the residents.
