The Issue

Should the City Council introduce Ordinance 09-694; an ordinance of the City Council of the City of Palos Verdes Estates, California, amending Section 18.05.040 of the Palos Verdes Estates Municipal Code Relating to the Procedure for Processing Applications for Sports Court Permits?

Background and Analysis

Currently, the municipal code states that the Planning Commission is to make a recommendation on Sports Court Permit applications to the City Council. Then, the City Council is to review the recommendation and make a final determination.

Procedurally, however, the Planning Commission reviews Sports Court Permit applications the same way it would review all other land use entitlements. Per Section 17.04.100, the Planning Commission is to make a determination at the Planning Commission meeting and then that decision is forwarded to the City Council. It is considered unnecessary for the City Council to review each Sports Court Permit application individually. Moreover, Sports Court Permit applications are often times submitted along with Neighborhood Compatibility or Grading Permit applications, thus it is considered more efficient to process these applications concurrently and under the same guidelines.

Ordinance 09-694 modifies Section 18.05.040 to require that Sports Court Permit applications be processed in compliance with the procedures outlined in Section 17.04.100. This ordinance will

ultimately make the municipal code consistent with the procedures historically utilized by the City to process Sports Court Permit applications.

Attached are copies of the proposed ordinance as well as the procedures currently outlined in Sections 18.05.040 and 17.04.100.

SUBJECT: REVIEW OF DISASTER SERVICE WORKER POLICY

DATE: NOVEMBER 10, 2009

Issue:

City Council review and comment on the proposed Disaster Service Worker policy.

Background and Analysis:

By definition, a disaster is an event or series of events the magnitude of which exceeds all available mitigating resources. Considering that our total strength of sworn police officers (regular and reserve) firefighters, members of public works and miscellaneous employees approximates 60, in time of a disaster we will necessarily rely heavily on volunteers to provide for our community of nearly 15,000 in population.

Through legislation, the State has provided a mechanism granting workers compensation limited liability indemnification for citizen volunteers of a disaster (Disaster Service Workers). California Code of Regulations, Title 19, 2570.2 (3)(b)(1) requires participating cities to adopt a DSW (Disaster Service Worker) policy by an Accredited Disaster Council to register Disaster Service Workers. In 1957, the City of Palos Verdes Estates Disaster Council was accredited, giving it the authority to develop policy for the establishment of a DSW program. Per Chapter 2.28 of the Palos Verdes Estates Municipal Code the City's Disaster Council is comprised of the Mayor, City Manager and other individuals who will assist in the coordination of PVE's emergency functions. It is that Disaster Council that must adopt the subject policy. A copy of Section 2.28 of the PVE Municipal Code is attached to this report.

The attached policy was created by staff with review and input by the City Attorney and the City council designated DDP Liaisons (Councilmembers Bird and Goodhart). The intent of this policy is multi-fold:

- 1). Provide greater protection to citizen volunteers during a disaster than that afforded by the Good Samaritan Law. This will also encourage the cooperation of citizen volunteers in a disaster.
- 2). Clearly outline a procedure for the recordation of DSW's including responsibilities for registration and maintenance of records.

- 3). Pre-designate volunteers who have demonstrated a desire and ability to be of assistance in a disaster. This will include CERT trained residents, members of NART, and of the DDP. The intent is to streamline the process rather than waiting until a disaster strikes before making the necessary registration. This would be accomplished preferably in a large group setting where the Mayor would administer the Oath and police department personnel would complete the recordation process.
- 4). Extend authority to the citizen district leaders to administer the Oath of Loyalty to perspective volunteers, at time of a disaster. This will afford them discretion to enlist the service of neighborhood experts. Without this provision, only elected officials and executive officers are authorized to administer that required oath.

From a process standpoint, it is appropriate for the entire City Council to review and provide input concerning the attached DSW Policy. Because of the unique decision making structure of the Disaster Council, the policy will need to be officially adopted by the Disaster Council as the final step in this process.

Alternatives Available To Council:

- 1. To review and comment on the attached DSW policy and forward it to the Accredited Disaster Council to take a formal action.
- 2. To suggest alterations to the DSW policy.
- 3. To chose not to review or comment on the DSW policy

Recommendations:

Staff recommends the City Council review and comment on the attached Disaster Service Worker Policy, and forward it to the Accredited Disaster Council for action.

SUBJECT: PALOS VERDES TENNIS CLUB FY 2010 OPERATING

AND CAPITAL BUDGETS

The Issue

Shall the City Council approve the FY 2010 Palos Verdes Tennis Club (PVTC) operating and capital budgets?

Analysis and Findings

The Palos Verdes Tennis Club concession agreement with the City requires that the Club's proposed operating and capital budget be reviewed and approved by the City Council. The Club uses the calendar year (January-December) as its fiscal year. The Club's Board of Directors approved the 2010 budget at its October meeting. On November 12, 2009, City Council liaisons Humphrey and Bird met with Club representatives, President Dave Kleinman, Treasurer Bruce Merchant and Manager John Hall, to review the budget.

The Club's 2009 adopted budget included an estimated profit of \$3,900. Based on results through the third quarter, the Club is projecting a very slight operating loss of less than \$300. Revenues for 2009 are projected at \$549,565 compared to the budget of \$595,500, or a decline of 7.7% (-\$45,935). While member dues and guest fees are slightly under budget (~-\$9,700), most of the decline is related to program and lesson revenue, which translate into direct savings on the expenditure side, as these revenues are paid in and then paid out in fees. Expenditures are projected at \$549,800 which represents savings of \$41,800 compared to the adopted budget (\$591,600).

The Club is monitoring revenues and expenditures very closely and made great effort to boost new memberships. The 2009 budget was based on 391 memberships and at one point during the year, the Club dropped to 378. At the Council liaisons' suggestion, the Club permitted a limited, one-time exception to the bylaws and allowed inactive members to reactive membership by paying 50% of one year's dues. Normally, payment of a full year dues is required. The Club had 8 inactive members rejoin as a result of the offer.

The current membership stands at 390, which forms the basis for the 2010 proposed budget. No dues increase is proposed for 2010. Monthly resident dues are \$65 and non-resident dues are \$85. Dues were last increased in 2006 (+\$10/month). There is no waiting list for Palos Verdes Estates residents.

The 2010 budget reflects a net profit of \$2,960 on revenue of \$555,450 and expenditures of \$552,490. Revenue represents a 1% increase compared to 2009 projected, while expenses reflect a 0.5% increase. Dues and guest fees equal 59% of total operating revenue. The junior program is budgeted at a profit of \$4,800, which is the same amount projected for the current year. The operating expenditures appear reasonable. Personnel costs for FY 2010 will remain unchanged from 2009. The challenge to the Club will be in meeting these slim margins and to maintain a slight operating surplus for FY 2010.

The 2009 capital program totaled \$35,500 and year-end expenditures, including replacement of clubhouse furniture, is expected to total \$33,400. Initiation fees from new memberships and installment payments on existing memberships are restricted for capital uses. Through September 2009, the Club realized new member fees of \$25,180 and projects total fees of \$30,500 for FY 2009. The projected ending capital balance for year-end is \$71,165.

The FY 2010 capital budget proposes only two items totaling \$27,000: \$12,000 for court resurfacing and windscreens, and \$15,000 as a contingency for emergency/infrastructure repairs. Initiation fee income for 2010 is projected at \$30,000 and the ending capital fund balance (12-31-10) is estimated at \$74,165.

The City Council liaisons will report on the meeting and endorse the proposed budgets.

Alternatives Available to the City Council

- 1. Approve the FY 2010 Palos Verdes Tennis Club operating and capital budgets.
- 2. Decline to approve the FY 2010 operating and capital budgets. This would require the Club and Board of Directors to change the budgets to address City Council concerns.

Recommendation

It is recommended that the City Council approve the FY 2010 Palos Verdes Tennis Club operating and capital budgets.

Budget Impact

The PVTC is a non-profit entity whose budget is separate from the City's. The PVTC pays a 10% concession fee on gross revenues (dues, guest fees, and food and beverage sales) to the City. The Club's budget includes a cost of \$33,650 for payment of these fees to the City.

Introduction

Should the City Council award a construction contract in the amount of \$322,000 to Hardy and Harper, Inc. for the completion of the FY 09/10 Overlay Project, and adopt Resolution R09-36 to adjust the Fiscal Year 09/10 Budget.

Background and Analysis

As part of the annual Capital Improvement Program, various streets receive an overlay treatment. The work consists of removing and replacing deteriorated asphalt, edge grinding, and overlaying the surface with new asphalt. The purpose of the work is to prevent any further deterioration of the roadway and restore the road to its original condition.

In April of 1996, the City Council approved a Pavement Management System (PMS) report that inventoried the conditions of all the City streets. The PMS was updated in 2003 and streets were ranked and prioritized based on their conditions and need for repair. Using the rankings designated for each street as well as recent field observations, staff identified the following streets for this year's overlay project:

In an effort to receive a number of competitive construction bids, staff advertised with Bid America, F. W. Dodge, and Reed Construction Data in June. Construction bids were received on June 25, at 10:30 a.m. City Council rejected all bids at the July 28 meeting to allow time for the County Board of Supervisors' office to respond to a request for additional project funding.

Staff bid the project again in October, with bids received on October 29, at 10:30 am. The base bid results are shown below, and a table comparing the base bids and eight alternate bids for the three lowest bidders is attached to this staff report.

- A2: repair of the existing flowline in front of 4028 and 4036 Via Opata, requested by the homeowners.
- A3: repair of the existing flowline area in front of 2416, 2424, and 2432 Chelsea Road, requested by the homeowner at 2424 Chelsea Road.
- A4: installation of an asphalt berm in front of 1641 Espinosa Circle, requested by the homeowner.
- A5: tree root removals requested by staff for various locations, shown on the attached list.
- A6: asphalt repair requested by staff for various locations, shown on the attached list.
- A7: overlay of Via Mirada from Via Panorama to the end of the cul-de-sac, requested by staff.
- A8: tree root removal and asphalt patching at 3644 Via Palomino, requested by the homeowner.

With regards to A1, please note that Cataluna Place is the street south of the median island, and Cataluna Square is the short section of roadway north of the island. The street has had a number of failures apparently caused by tree roots and old poorly compacted utility trenches (maybe even from sewers built in the 1960s). The pavement has failed significantly, especially within Cataluna Place near the median island. Staff has had many resident complaints regarding this area over the past few years.

With regards to A7, Via Mirada, staff has observed deterioration of the street and the alligator cracking over time, and anticipates the alligator cracking will soon turn into potholes requiring more expensive repairs. We have no complaints from the residents regarding the condition of the asphalt.

When our PMS was updated in 2003, Cataluna Place, Cataluna Square, and Via Mirada were in such good condition that they were excluded from the report for needing any maintenance. The

fact that they have both deteriorated to this extent raises the issue of whether the PMS needs to be updated with the current condition of all the streets in the City and updated projections of needed repairs/maintenance. We will bring this forth as a budget issue paper during the next budget cycle.

With regards to A8, the homeowner submitted a request recently to have the street in front of their driveway resurfaced because of improper drainage. According to the homeowner, the issue is related to the City slurry seal project that occurred there several years ago. Upon investigation staff found that roots from a City tree had uplifted several of the nonstandard driveway approach bricks in the right-of-way and subsequently a portion of approach is missing that would have directed runoff toward the catch basin in front of their home. Since the owner did not want to put in a standard approach or repair that section of approach, the alternative option is for the City to remove more of the uplifted nonstandard bricks, perform tree root removal while minimizing damage to the tree, grind asphalt and concrete where necessary, and patch portions of the concrete driveway and street with asphalt.

Hardy and Harper, Inc. submitted the qualifying low bid for the project. They have completed many projects of similar size and scope, and City staff has also worked with them before, on the FY 04/05, FY 06/07, and FY 07/08 Overlay Projects, as well as on the May 2009 LACMTA Flexible Funding paving project. Staff believes they are well equipped to satisfactorily complete the City's project.

The following schedule is anticipated:

• November 24 Contract awarded.

• December 18 Contract, insurance certificates signed by contractor & City.

• December 28 Work expected to begin.

• January 29 Work expected to be complete.

Alternatives Available to Council

The following alternatives are available to Council:

- 1. Award a construction contract in the amount of \$322,000 to Hardy and Harper, Inc. for the completion of the FY 09/10 Overlay Project, with no alternative work, and adopt Resolution R09-36 to adjust the Fiscal Year 09/10 Budget.
- 2. Award a construction contract in the amount of \$411,895 to Hardy and Harper, Inc. for the completion of the FY 09/10 Overlay Project including alternates A2 through A6, and adopt a Resolution to adjust the Fiscal Year 09/10 Budget.
- 3. Award a construction contract to Hardy and Harper, Inc. for the completion of the FY 09/10 Overlay Project with some alternative work, to be chosen by Council, and adopt a Resolution to adjust the Fiscal Year 09/10 Budget.

4. Decline to Act.

Conclusions and Recommendations

Staff recommends that at least Alternate bids A2 through A6 be awarded with the base bid on this project, for a total construction cost of \$411,895. Staff bases this recommendation on our perception of the relative need for each of the Alternates, as well as the price for each.

Therefore, staff recommends that the City Council award a construction contract in the amount of \$411,895 to Hardy and Harper, Inc. for the completion of the FY 09/10 Overlay Project including alternates A2 through A6, and adopt a Resolution to adjust the Fiscal Year 09/10 Budget.

Fiscal Impact

The FY 09/10 budget contains \$275,000 for the overlay of City streets. Should Alternatives A2 through A6 be included in the contract, estimated project costs would be:

An additional \$223,085 would be needed to cover the total project budget. Slurry Seal Project remaining funding is available in the amount of \$99,800. An additional \$54,425 is available from remaining LACMTA funding that can be applied to work on Granvia Altamira, leaving a balance of \$68,860 that would require additional funding. Resolution R09-36 providing for the transfer of funding to this project is attached.

The Issue

Should the City Council approve Resolution R09-35 authorizing the submittal of a funding application to the California Energy Commission to implement energy efficiency improvements at Palos Verdes Estates City Hall?

Background and Analysis

As part of the American Recovery and Reinvestment Act, the Department of Energy has implemented the Energy Efficiency and Conservation Block Grant Program (EECBG), which provides non-competitive formula grants and competitive grants to U.S. local governments, states, territories, and Indian tribes to fund programs and projects that improve energy efficiency and reduces energy use and fossil fuel emissions.

The City of Palos Verdes Estates has been allocated \$75,858 as part of this non-competitive formula grant process. Additional EECBG funding will also be available competitively to local governments through the California Energy Commission. However, the criteria for competitive funding have yet to be released.

Energy Innovation Group, LLC (EIG) is under contract with the South Bay City of Governments to assist cities in applying for funding from the EECBG. A number of other cities in the South Bay (Rolling Hills Estates, Lawndale, Hermosa Beach, Lomita, and El Segundo) are using these services to complete energy audits and determine projects for funding through the EECBG.

EIG's report for City Hall recommends the following:

Replace Older Heat Pumps with High-Efficiency Heat Pumps:

Replace the existing 1991 2.5-ton split system at 911 Room, (2) 1993 3-ton split system at Police Department, (1) 1993 5-ton split system at City Hall Council Chambers and (2) 1993 7.5-ton split system heat pump units at City Hall and split-systems with high-efficiency units and systems. The plan would be to replace the systems with new Energy Star systems and replace or repair ducting and add components as needed. The goal is to achieve maximum energy conservation while reducing the Palos Verdes Estates Carbon Footprint, and increasing reliability and efficiency.

Upgrade HVAC Units with CMUs:

Upgrade six existing 2.5-ton and larger single-package units, heat pumps and split-system air conditioning systems at the 911 Room, City Hall, City Hall Council Chambers and Police Department with CMUs (Compressor Management Units) to provide microprocessor based control over compressor cycle run time and time between cycles in direct response to monitored actual conditioned space cooling load requirements. The goal is to achieve maximum efficiency of each unit.

Upgrade HVAC Cooling Coils with UVC Emitters:

Upgrade 14 existing and proposed heat pump cooling coils located at City Hall, Police Department and City Hall with UVC (ultraviolet C-Band) emitters to destroy microorganism and prevent growth and fouling on cooling coils and interior air handler and duct surfaces. The continuously cleaned coils reduce airflow fan motor energy use, improve coil efficiency lowering DX system compressor energy use, reduce operations and maintenance cost by eliminating coil cleaning and improve air quality. The goal is to achieve maximum efficiency of each unit.

Based on EIG's preliminary \$75,858 cost estimate for the above projects, and taking into account the available stimulus funding and Edison rebates (which total \$81,643 in available funding), it appears that the City will be able to complete these improvements without a financial contribution from our budget. Again, the \$75,858 is an estimate; EIG will solicit bids to determine exact costs. As outlined in the report, the above projects will achieve annual energy savings of approximately \$7,139 for the City of Palos Verdes Estates.

The recommendation is to adopt the attached resolution which authorizes PVE's submittal of a funding application to the California Energy Commission. The next step in the process will be for EIG to seek bids from HVAC contractors to complete this work. Assuming the bids are within the estimates as outlined in the report, the City and EIG will submit the funding application to the California Energy Commission. The final deadline for the submittal of the funding application to the California Energy Commission is January 12, 2010.

Alternatives Available to Council

The following alternatives are available to the City Council:

- 1. Approve Resolution R09-35 authorizing the submittal of a funding application to the California Energy Commission to implement energy efficiency improvements at Palos Verdes Estates City Hall
- 2. Approve Resolution R09-35 authorizing the submittal of a funding application to the California Energy Commission to implement energy efficiency improvements at Palos Verdes Estates City Hall, with modifications.
- 3. Decline to Act.

Recommendation from Staff

Staff recommends that the Council:

Approve Resolution R09-35 authorizing the submittal of a funding application to the California Energy Commission to implement energy efficiency improvements at Palos Verdes Estates City Hall.
