The Issue

What is the status of the FY 2010-11 budget after eight months?


Analysis of Graphs

Revenues continue to slightly lag expected. General fund revenues are 1% less than expected and total operating revenues are 4% less than expected. All major revenues are within acceptable ranges compared to budget. The next milestone for revenue results will be reflected in the April report, when the City will have received all annual utility franchise fee payments (water, gas and electric), which are budgeted at just over \$300,000. April will also bring another major allocation for property tax and direct assessment receipts (fire parcel tax and sewer fee). These results will provide a firm basis for projecting year-end revenues.


Operating expenditures are at or below expected levels with total operating expenditures 5% less than expected, the exception being insurance due to a discounted, advance payment of a retro deposit liability. The Police Department results reflect position vacancies and the lack, so far, of unforeseen (emergency) expenditures. None of the other department expenditure results are cause for concern. The April expenditure results will include three pay periods for that month and operating department performances will likely track more closely to expected at that time.

The Issue

Should the City Council extend the Tree Trimming, Landscape Maintenance, and Weed Abatement/Fire Safety Contracts?

Background and Analysis

This is the time of year when we traditionally request bids for the three subject contracts, or ask the Council for extensions to these contracts. Traditionally we have extended contracts when we have been very satisfied with the level of service and when the contractor offers to extend the contract at the original bid prices. In essence we rely upon the original competitive-bid process as an assurance that we have the lowest bid prices.

The following table summarizes the contracts:

Services	Contractor	Year Bid	Amount
Street Sweeping	Dickson	2009	\$85,320
Landscape Maintenance	Merchants Landscape Service	2008	\$221,376
Weed Abatement/Fire Safety	Oakridge Landscape Inc.	2009	\$96,294

Staff is extremely satisfied with the performance of all three contractors. Each has submitted a letter offering to extend their contract for an additional year at the prices they provided in their original bid. Staff would like to extend each contract for an additional year at the originally bid prices. It is possible that we could conceivably achieve lower prices if we competitively bid the contracts, but we run the risk of being forced to work with a contractor that would perform far below the level of the current contractors.

In regards to the Street Sweeping Contract, Dickson has been with the City for many years and has a specific provision within their contract to extend it for another year. We are very satisfied with their service and receive virtually no complaints from the public.

In regards to the Landscape Maintenance Contract, Merchants has performed the best on this contract in anyone's memory. They have provided the right level of staffing to match the varying level of maintenance needs throughout the year, especially during the springtime. They have provided a consistent onsite supervisor who quickly learned our needs and has performed very well.

Finally, in regards to the Weed Abatement/Fire Safety Contract, Oakridge performed fabulously and completed the contract far quicker than the allotted period during the past two years. The bid of \$96,294 was far less than the next low bid of \$121,600. Staff was skeptical prior to the work that they could complete it at this low price, but found that due to their vast experience with contracts of this nature that they could come in with the correct level of staff and equipment and quickly finish the work.

Alternatives Available to Council

The following alternatives are available to the City Council:

- 1. Extend the Street Sweeping Contract with Dickson, Landscape Maintenance contract with Merchants Landscape Services, Inc., and Weed Abatement/Fire Safety contract with Oakridge Landscape, Inc., for one year at the previously bid prices.
- 2. Extend one or more of the Street Sweeping, Landscape Maintenance, and Weed Abatement/Fire Safety Contracts for one year at the previously bid prices.
- 3. Direct staff to seek competitive bids for all three contracts.

Recommendation from Staff

Staff recommends the City Council extend the Street Sweeping Contract with Dickson, the Landscape Maintenance contract with Merchants Landscape Services, Inc., and Weed Abatement/Fire Safety contract with Oakridge Landscape, Inc., for one year at the previously bid prices..

The Issue

Should the City Council award a professional services agreement in the amount of \$66,300 to Psomas for groundwater investigation services in and around Malaga Cove Plaza?

Background and Analysis

Groundwater within and around the Malaga Cove Plaza has been a significant issue for many years. Over time there has been an increase in the number and frequency of sinkholes caused by water intrusion into underground utilities, as well as electrical failures due to water filling underground electrical facilities. A subdrain built in the alley behind Malaga Cove Plaza in 1997 has been found to be near the end of its useful life. Recent measurements in the monitoring wells show that the groundwater is at all-time highs, probably due to the rains late last year.

On January 13, 2010 the Council reviewed a study funded by outside agencies and prepared by RMS Water and Environment (RMS) on the groundwater and whether the water could be economically used by the nearby golf course. The study concluded that the effective cost of groundwater due to a variety of factors would be twice the cost of using potable water. Due to concerns raised by staff, the consultant, and members of the community about the potential for adverse impacts due to the effects of groundwater in the Malaga Cove Plaza area, the Council directed staff to prepare a scope and budget for an additional investigation.

Staff presented the scope and budget to the City Council and said budget was included within the City's FY 2010/11 budget in the amount of \$20,000. An additional \$10,000 was placed in the FY 2011/12 budget and \$30,000 in the FY 2012/13 budget, for a total of \$60,000. The timing of the expenditures was based on correspondence we received from a groundwater consultant, Ninyo and Moore, who suggested that we would need time to monitor the groundwater for two years to complete the study.

A Request for Proposal (RFP) was prepared and provided to two consultants who had previously performed groundwater investigations in the area, as well as to a firm that distributes RFPs to engineering firms in Southern California. We received three proposals from the two firms we were familiar with, Worley Parsons and Ninyo and Moore, and from an additional firm Psomas. Staff reviewed all three proposals and felt that the proposal from Psomas provided the best approach to understanding the groundwater issues and had the best experience with similar projects. The firm and the two lead individuals have prepared many similar groundwater models and have much more experience than the other two firms.

Please note that when staff solicited proposals, the details of how best to accomplish the monitoring were left to proposers as we did not feel confident in specifying the methods as we are not experts in groundwater investigation. Each of the three firms proposed a different approach and associated costs. Although we did not use the proposed costs as part of our selection process, the following are the proposed costs from the three firms:

Psomas	\$45,600
Worley Parsons	\$16,500
Ninyo/Moore	\$49,500

After reviewing the proposal, staff discussed the project in-depth with Michael Donovan of Psomas and determined that their proposed approach could be improved with the installation and monitoring of three wells. These wells would help calibrate and validate the numerical model that Psomas would create of the groundwater basin. Once the numerical model is completed, Psomas can evaluate the alternatives to remove and potentially reuse the groundwater. The added cost for Psomas to do the monitoring is \$20,700

The total proposed cost for these services is \$66,300. If the work begins soon, we would expect the services would be completed by the end of FY 2011/12. We will adjust the budget accordingly during the next year's budget preparation.

Alternatives Available to Council

The following alternatives are available to the City Council:

- 4. Award a professional services agreement in the amount of \$66,300 to Psomas for groundwater investigation services in and around Malaga Cove Plaza.
- 5. Decline all proposals and direct staff as appropriate.
- 6. Decline to act.

ISSUE

Shall the City Council approve Wells Fargo Insurance Services to provide Employee Benefits Insurance Broker and Consulting Services for the City's health and ancillary benefits?

BACKGROUND

The City of Palos Verdes Estates contracts with insurance firms to provide medical, dental, and other group insurance programs available to full-time City employees. The City works closely with an insurance broker to provide these insurances at the highest level of service and the best cost to the City and its benefited employees. ISU-ERG Insurance Agency (previously Olson Duncan & Dickins) has been the City's broker of record since 1997 after the completion of a Request for Proposals. Prior to 1997, the City worked with ERG's Principal under the California Joint Powers Insurance Authority's health benefit program.

In light of new Healthcare Reform laws coupled with keeping the City's health insurance costs to a minimum, in December 2010, the City issued a Request for Proposals (RFP) for Employee Benefits Insurance Broker and Consulting Services. Seven proposals were received on or before the close date of January 26, 2011. Proposing firms include: Alliant, Barney & Barney, California Corporate Benefits, ISU-ERG Insurance Agency, Keenan & Associates, Maniaci Insurance Services, and Wells Fargo Insurance Services.

ANALYSIS

Proposals were reviewed by the City Manager, Assistant City Manager and Administrative Analyst. Proposals were evaluated based on the qualifications of the firm and its project staff, understanding of the project as evidenced by items offered and cost, and their overall experience. Two finalists were selected among the seven proposing firms: ISU-ERG (the City's current broker) and Wells Fargo Insurance Services.

ISU-ERG, the City's current broker, proposed to maintain the City's current insurance offerings and add pro bono components, such as COBRA administration, enhancements to the City's Wellness program, and access to human resources and legal compliance information. The City of Palos

Verdes Estates is the only public entity in which they provide a full-package of insurance services. They provide services to one other City for ancillary benefits only. Although there are no fees directly charged to the City, ISU-ERG earns its revenue based upon a percentage commission paid by the insurance firms determined by the amount of premium paid by the City. The revenue is estimated between \$30,000 and \$41,000.

Wells Fargo Insurances Service is a larger firm that offers comparable services provided by the City's existing broker. As part of their service, Wells Fargo Insurance Services offers human resources, legal compliance resources, and an employee advocacy service. In addition, Wells Fargo has over 200 governmental entities, of those 150 are cities. As such, they have a proprietary public sector program whereby over half of their municipal clients participate in some form. Wells Fargo Insurance Services also earns its revenue based upon a percentage commission paid by the insurance firms; not to exceed \$30,000.

After meeting with both finalists and completing reference checks, staff recommends that the City change brokers to Wells Fargo Insurance Services and enter into a Professional Services Agreement with a three-year term and two options for a two-year extension.

The team of five from Wells Fargo Insurance Services that would be assigned to the City consists of licensed professionals, educated and trained in various specialties ranging from group underwriting, claim and billing resolution, legislative compliance, contract review, strategic planning, and employee education and communication. In staff's analysis, Wells Fargo Insurance Services will provide the City with a professional team and resources to successfully sort through the new healthcare reform laws and its applicability to the City. They have on-staff experts on the law, as well as in-house attorneys. This will be a valuable tool as healthcare reform mandates are implemented over the next several years.

Additionally, Wells Fargo Insurance Services has a significant part of the public agency market. As such, they understand the many challenges public agencies are facing with increased public scrutiny, retirement reform, labor relations, etc. Every two years, they provide a California Municipality Employee Benefits Trends Survey as resource to their clients. Also, as part of their unique service, they offer options to public sector organizations through their Multiple Choice and Municipal Benefits Pool. Both programs offer a range of plan options as an additional alternative for the City's insurance plans. Although the City does not expect to change insurance carriers over the next plan year, this may allow some reductions to the premiums since some of the City's current carriers currently are part of the Municipal Benefits Pool.

Staff contacted four city clients of Wells Fargo Insurance Services as references. All references highly recommended the broker. References expressed a high-level of satisfaction of services performed and responsiveness to concerns. They were described as being very attentive to both the client and the client's employees' needs. Wells Fargo was explained as being an extension to the Human Resources Department, stocked full of resources. Experience with the municipal pools was reported as very positive.

ALTERNATIVES

- 1. Approve Wells Fargo Insurance Services to provide Employee Benefits Insurance Broker and Consulting Services for the City's health and ancillary benefits.
- 2. Reject the recommended Broker and maintain the current Broker.
- 3. Reject all responses and issue a new RFP for services to take effect in FY 2012-13.

RECOMMENDATION

It is recommended that the City Council approve Wells Fargo Insurance Services to provide Employee Benefits Insurance Broker and Consulting Services for the City's health and ancillary benefits.

OF GOVERNMENTS (SCAG)

Issue:

Shall the City of Palos Verdes Estates join the Southern California Association of Governments (SCAG)?

Background:

The Southern California Association of Governments (SCAG) is the nation's largest Metropolitan Planning Organization, representing the six counties (Imperial, Los Angeles, Orange, Riverside, San Bernardino and Ventura) and 187 cities that make up the Southern California region. SCAG has increasingly served as a unifying voice for Southern California, advocating for regional priorities in Sacramento and Washington, D.C.

SCAG has been designated a joint powers authority (JPA) established under California law, meaning that it is based on an association of local governments and agencies who voluntarily come together on issues of common concern. SCAG is mandated by the Federal and State governments to develop regional plans for transportation, growth management, housing development, air quality and other issues of regional significance.

In Southern California, SCAG is the forum where local leaders converge to discuss common problems and develop common solutions to shared regional challenges. In order to ensure that Palos Verdes Estates has a voice in important issues that SCAG is currently mandated to oversee, it is recommended that the City become a member.

Discussion:

To date, the City of Palos Verdes Estates has not chosen to become a member of SCAG. Organizations such as SCAG allow smaller municipalities to have a larger voice when it comes to regional issues; as well as State and Federal issues.

The core functions of SCAG include:

a. Exchange of objective planning information that affect local governments;

- b. Identification and study of problems and the making of appropriate policy or action recommendations:
- c. Review and/or develop governmental proposals and proposals creating agencies of regional scope, and the making of appropriate policy or action recommendations concerning the need for such units or agencies;
- d. Consider questions of common interest and concern to members of the Association and may develop policy and action recommendations of an advisory nature only; and;
- e. Act upon any matter to the extent and manner required, permitted or authorized by the joint powers agreements, State or Federal law, or the regulations adopted pursuant to any such law.

Under Federal and State law, SCAG is designated as a Metropolitan Planning Organization (MPO), a Regional Transportation Planning Agency (RTPA) and a Council of Governments (COG). As a designated MPO under Federal law, SCAG is responsible for developing and adopting a long-range Regional Transportation Plan (RTP) every four (4) years; and developing and approving a short-term Regional Transportation Improvement Program (RTIP) every two (2) years. The RTP serves as a basis for transportation decision making in the region. If a particular highway, road or transit improvement is not represented in the RTP, it cannot receive State or Federal funds. The RTIP is a plan which determines and prioritizes how much Federal funding State and local agencies receive in a five-year time span.

Under State law as a Council of Governments (COG), SCAG is responsible for developing a portion of the Air Quality Management Plan (AQMP) prepared by the South Coast Air Quality Management District (SCAQMD); a Regional Housing Needs Assessment (RHNA) to determine each jurisdiction's fair share of the region's future housing needs, as determined by the State Department of Housing and Community Development; pursuant the California Environmental Quality Act (CEQA) undertakes the appropriate environmental review for the RTP and RTIP; and may prepare a regional hazardous waste management plan to identify hazardous waste management issues at the regional levels.

When a jurisdiction joins SCAG, a new seat is created on the SCAG General Assembly. Representatives to the Assembly elect officers, adopt SCAG's annual work program, set the agency's planning and policy priorities, and approve the study of specific problems, programs and other matters that concern the region. The City would designate one delegate and one alternate from the City Council to sit on the General Assembly. SCAG facilitates and encourages coordination and cooperation among multiple levels of government for the greater benefit of all. By joining SCAG, the City would be guaranteed a seat at the table where solutions to regional problems are formulated and later implemented.

Fiscal Impact:

Based on the City of Palos Verdes Estates population, the FY 2010-11 membership dues are \$1,288. Since the City would be joining mid-year, the membership dues are prorated in the amount of \$322.08 for April 1, 2011 – June 30, 2011.

Recommendation:

That the City Council authorize (1) the City Manager to submit the City's request for membership and pay membership dues to the Southern California Association of Governments (SCAG); (2) the City Manager to sign the SCAG Joint Powers Agreement that is necessary for membership; and (3) the Mayor to appoint a delegate and alternate representative to the SCAG General Assembly from the City Council.
