The Issue

Should the City Council:

- Accept as complete the construction contract PW 544-08; FY 08/09 Curb and Gutter Replacement Project in the amount of \$19,595; and

Background and Analysis

On February 24, 2009, City Council awarded a Contract in the amount of \$18,885 to Grigolla and Sons Construction Company for the completion of the FY 08/09 Curb and Gutter Replacement Project. The project repaired curb, curb and gutter, or sidewalk in various locations throughout the City as requested by residents and deemed necessary by staff.

One change order was issued for the project, for \$710 to add curb and gutter on Palos Verdes Blvd and sidewalk on Via Corta, and to delete curb and gutter in other areas. The project has now been satisfactorily constructed for the amount of \$19,595 (+3.8%).

Alternatives Available to Council

The following alternatives are available to the City Council:

- Accept as complete the construction contract PW 544-08; FY 08/09 Curb and Gutter Replacement Project in the amount of \$19,595, direct the City Clerk to file the Notice of Completion, and release the 10% retention 30 days after the County Recorder's office records the Notice of Completion, if no stop notices are filed.
- 2. Decline to accept the project as complete.

The Issue

Should the City Council:

Background and Analysis

On February 10, 2009, the City Council awarded a Contract in the amount of \$194,758.88 to Palp Inc. DBA Excel Paving Company for the completion of the Via Campesina, Via Valmonte, Palos Verdes Drive North Paving—LACMTA Flexible Funding Project. The project was a combined overlay and slurry seal street improvement project. The overlay portion occurred on Via Campesina from Palos Verdes Drive North to the edge of the new pavement at the east golf course entrance, on Palos Verdes Drive North from the triangle intersection to Paseo Del Campo, and on a very small portion of Via Zumaya next to 2564 Palos Verdes Drive West. The slurry seal project occurred on Via Valmonte from Palos Verdes Drive North to Via Azalea.

The project has now been satisfactorily completed in the amount of \$204,211.68. Additional pavement repairs were needed on Via Campesina, Palos Verdes Drive West, and Via Valmonte and added to the project cost. The slurry seal resurfacing was also changed to Type II slurry seal from rubberized emulsion aggregate slurry seal (REAS), because the spring cool weather conditions would have extended the drying time for REAS beyond acceptable limits. Regular Type II slurry seal does not have crumb rubber from recycled tires as does REAS, so it does not

retain its black coloring as long, but does dry much more rapidly and provided a slight cost savings that was applied to pavement repairs. The minimum drying time for REAS is four hours on a fairly hot day and the optimum season to install it is during the summer. In cooler weather and in shaded areas, the conditions occurring during the construction, drying times can extend to overnight and longer.

One change order was issued for \$9,452.80, which increased the total construction cost to \$204,211.68 (+4.9%). The 10% contingency budget, approved by Council when the project was awarded, provided the funding for the change order.

Alternatives Available to Council

- Decline to accept the project as complete.

The Issue

Should the City Council:

- 1) Accept as complete the construction contract PW 553-08; EVR II Upgrade Project in the amount of \$41,825; and

Background and Analysis

On March 10, 2009, the City Council awarded a Contract in the amount of \$41,825 to Fleming Environmental Inc. for the completion of the EVR II Upgrade Project. The project installed a Veeder-Root vapor recovery canister onto the existing fuel tank ventilation line, installed an electrical circuit to power the vapor recovery canister, upgraded the City's existing Veeder-Root alarm console, and installed a new dispensing unit equipment to comply with C.A.R.B. and SCAQMD requirements. System tests were conducted after all installations had taken place, in accordance with SCAQMD requirements. Fleming Environmental informed SCAQMD and County inspectors of the tests so that they could make arrangements to attend if they wished.

The project has now been satisfactorily completed in the amount of \$41,825 with no change orders issued.

Alternatives Available to Council

The following alternatives are available to the City Council:

- 1. Accept as complete the construction contract PW 553-08; EVR II Upgrade Project in the amount of \$41,825, direct the City Clerk to file the Notice of Completion, and release the 10% retention 30 days after the County Recorder's office records the Notice of Completion, if no stop notices are filed.
- Decline to accept the project as complete.

Recommendation from Staff

Staff recommends that the Council:

The Issue

Should the City Council introduce Ordinance No. 09-689, an ordinance of the City Council of the City of Palos Verdes Estates, amending Section 18.32.010 of the Palos Verdes Estates Municipal Code relating to heights of walls, fences, and accessory structures in the R-1 and R-M zones?

Background and Analysis

Chapter 18.32 of the City's Municipal Code includes restrictions to the height of walls and fences on private property. However, there are many items that fall outside the definition of walls and fences that can create significant impacts if above the maximum allowed heights. These include trellises, gazebos, playhouses, decorations, fireplaces, and fountains. It is necessary to expand the scope of structures required to comply with the established heights so that impacts can be properly assessed.

This topic was originally discussed at the joint dinner meeting on January 28, 2009. After much discussion, it was decided that staff was to work with the City Attorney to revise the walls and fences section of the code to include trellises, gazebos, playhouses, decorations, detached fireplaces, fountains, and other structures as deemed appropriate by the Planning Department.

The main modification to this chapter is the addition of the term "accessory structure". Sections D and E have also been added to define the term "accessory structure" and to note that a silhouette may be required at the discretion of the Planning Director and/or Planning Commission. Currently, walls, fences, and accessory structures are not required to be silhouetted; however, there may be

cases in which a silhouette is appropriate. For example, a new guest house may have an impact on an adjacent neighbor and a silhouette can clearly show that impact.

Attached is a copy of the existing format of Chapter 18.32, the red-lined version of Chapter 18.32, and the proposed ordinance.

The proposed ordinance was reviewed and approved by the Planning Commission at their meeting on April 21, 2009.

The Issue

Should the City Council award the street sweeping contract in the amount of \$85,320 annually to R.F. Dickson Co, Inc., for Fiscal Years 09/10 and 10/11?

Background and Analysis

The existing Street Sweeping contract is due to expire June 30, 2009. To ensure that the City's street sweeping needs are fulfilled without any interruption in service, staff has completed the re-bid process and is seeking an award of this contract for a start date of July 1, 2009.

Staff chose to maintain the contract length at two years with a contract provision included for two one-year options for extension, to take advantage of any reduction in costs that may occur by June 30, 2011.

The contract was bid as Bid Item #1 regular sweeping, with three alternate scopes, and Bid Item #2, an hourly rate for additional sweeping. The table below summarizes the different alternate street sweeping schedules for Bid Item #1, with Alternate A being the current schedule:

Bids were based on approximate lengths of 21 curb miles for the commercial route and 146 curb miles for all remaining streets and alleys. The streets that make up the commercial route are Palos Verdes Drive West, Palos Verdes Drive North, Palos Verdes Boulevard from the Torrance border to Palos Verdes Drive West, Via Corta, Via Chico, Via Tejon, Tejon Place, Yarmouth Road (two

blocks), Via Anacapa (two blocks), Malaga Cove Plaza, and the parking lot just west of City Hall adjacent to Palos Verdes Drive West.

Staff advertised in F. W. Dodge, Bid America, and Reed Construction Services, and also contacted nine local street sweeping companies. Three bids were opened on April 22, 2009, at 10:30 a.m. The bidders were R.F. Dickson Company, Clean Street, and Nationwide Environmental Services. The bid results are as follows:

R.F. Dickson Co., Inc. has satisfactorily provided street sweeping services to the City since 2000 under three previous contracts. Their annual cost for Alternate A, the current sweeping schedule, will allow the City to continue to sweep commercial routes weekly.

Although Alternate C is less expensive, the commercial routes are the most heavily traveled in the City and the debris that would collect with an Alternate C schedule is significant. However, should the Alternate C schedule be selected, the proposed reductions in street sweeping frequency would be acceptable and would comply with National Pollutant Discharge Elimination System (NPDES) requirements.

Alternatives Available to Council

The following alternatives are available to the City Council:

- 1. Award the street sweeping contract in the amount of \$85,320 annually to R.F. Dickson Co, Inc., for Fiscal Years 09/10 and 10/11.
- 2. Award the street sweeping contract with a different schedule and cost.
- 3. Decline to Act.

Recommendation from Staff

Staff recommends that the Council award the street sweeping contract in the amount of \$85,320 annually to R.F. Dickson Co., Inc., for Fiscal Years 09/10 and 10/11.

Fiscal Impact

The annual \$85,320 bid amount is greater than the current FY 09/10 street sweeping budget of \$61,900. A budget adjustment of \$23,420 can be made upon awarding the contract.

The City will have two one-year options to extend the contract at a mutually agreed upon price by both parties.
