## **The Issue**

Should the City Council concur with the Parklands Committee's recommendation to allow an area of turf and a statue to remain within the parklands adjacent to 1602 Espinosa Circle?

# **Background**

The Parklands Committee reviewed and approved (5-0) an application to retain turf and a statue in the parklands adjacent to 1602 Espinosa Circle at their meeting of June 13, 2011. At the City Council meeting on June 28, 2011, the City Council directed that this item be removed from the Council's agenda for review at a later date. Attached to this memo is the report that was reviewed by the Parklands Committee and the relevant portions of the minutes from their meeting.

Please note that there is a letter attached to the report that argues that the Parklands Committee is the wrong venue to review this application. Prior to scheduling this for the Parklands Committee review, staff confirmed with the City Attorney's office that neither the turf nor the statue were either a "structure" or a "facility" which would require review by the Planning Commission.

Staff was contacted by the resident of 1602 Espinosa Circle after the June 28, 2011 Council meeting. The resident indicated that he would immediately remove the statue from the parklands and to reduce the application to only include the turf. Please note this does not change the recommendation from the Parklands Committee, but effectively removes the statue from the application.

## **Alternatives Available to Council**

The following alternatives are available to the City Council:

- 1. Concur with the Parklands Committee and allow the resident of 1602 Espinosa Circle to maintain an area of turf and a statue within the parklands adjacent to 1602 Espinosa Circle.
- 2. Concur with the Parklands Committee and allow the resident of 1602 Espinosa Circle to maintain an area of turf within the parklands adjacent to 1602 Espinosa Circle, but deny the resident to maintain the statue in the parklands.
- 3. Deny the resident of 1602 Espinosa Circle to maintain an area of turf and a statue within the parklands adjacent to 1602 Espinosa Circle and direct that both be removed.

# **The Issue**

Should the City Council approve a professional services agreement in the amount of \$9,800 to the KOA Corporation for review and engineering design of traffic calming improvements on Via Del Monte?

# **Background**

Traffic concerns on Via del Monte have been raised by residents of the street many times over the years. Based on a significant number of concerns raised in June of 2004, the City retained an outside consultant, KOA Corporation (KOA), to complete a traffic study on Via Del Monte at a cost of \$7,000. The completed study proposed a "toolbox" of potential traffic calming measures that a group of residents could choose from for their portion of the street. A resident-initiated application would still need to be reviewed through the City's traffic calming process to assure the measures were truly desired by the impacted residents. Until late in 2010 we had not received a traffic calming application from the residents.

In August of 2010, residents on Via Del Monte, along with the Malaga Cove Homeowners Association, submitted a Traffic Calming application based on measures within the KOA study. Staff developed a plan of proposed measures, which did not include two sets of speed cushions at 561 and 573 Via Del Monte, due to the grade of the road and objections of the resident adjacent to the proposed location, in accordance with the Traffic Calming Policy that provides no device will be installed when opposed by the affected property owner. The application/plan was then reviewed and recommended for approval by the Traffic Safety Committee with a subsequent review and approval by the City Council. The measures consisted of stenciling, signage, which were implemented immediately and two sets of speed cushions, which were installed in February of 2011. The City Council reviewed the effectiveness of all measures in May of 2011 and approved them all to remain.

At the May meeting, the City Council additionally directed staff to determine additional measures for traffic calming on Via Del Monte. As KOA was previously selected to provide traffic calming services for Via Del Monte, staff contacted them to provide additional traffic calming services. As the previous study had been performed six years ago, we felt that it would be wise to determine if new measures might be more effective than those proposed before, especially as the science of traffic calming continues to evolve.

Staff additionally heard from the Council that the City should take a different approach to traffic calming measures on Via Del Monte than the citizen-initiated process as dictated in our Traffic Calming Policy. The need for traffic calming on Via Del Monte is very well defined and Council expressed the desire that the City should take the lead in this process. As such, we have asked KOA to take the next step and propose to provide preliminary engineering drawings and cost estimates based on their updated review of potential measures. These can easily be modified to become construction documents.

The proposal from KOA indicates that they will provide two tiers of traffic calming recommendations. The first tier measures include those which do not include major roadway reconstruction, such as striping, stenciling, and electronic signage. The second tier measures require major roadway reconstruction and/or involve corridor-wide improvements, such as median islands, chicanes, and roundabouts. Please note that the study completed in 2005 by KOA primarily included these second tier type improvements which can create significant negative impacts such as the elimination of parking along the street and restricted access to driveways. Although there were individual, rough cost estimates for each measure identified in the 2005 study, there was no overall plan and these estimates need to be updated to reflect current costs.

The first step in the process will be the "Traffic Calming Review and Recommendations" portion of the KOA proposal. They will identify measures they believe would be best suited for Via Del Monte in a similar format to what they performed in 2004. The existing speed cushions will not be reviewed, unless Council directs that an alternate to the existing cushions be considered. The report will be reviewed by the Traffic Safety Committee at their September meeting and then by the City Council. Based on the approved measures, KOA will then proceed with the second step in their proposal which is "Preliminary Engineer Design and Estimates". They will create a preliminary construction document and estimates so that the Traffic Safety Committee and City Council can make a final decision on a comprehensive plan for Via Del Monte.

Depending on the measures proposed, this may be a complete enough document for bidding purposes. If measures such as chicanes or median islands are selected, there may be additional design work needed, which would then require additional fees. It is too early to determine if this additional design work will be needed.

The City Council has previously raised the issue of updating the City's adopted Traffic Calming Program. It would seem that new measures and methodologies identified as a result of this KOA study could be included in an update to the Policy. As such we would work with the Traffic Safety Committee to review the new KOA study/design, its applicability city-wide and to then revise our Traffic Calming Program.

# **Alternatives Available to Council**

The following alternatives are available to the City Council:

- 1. Approve a professional services agreement in the amount of \$9,800 to the KOA Corporation for review and engineering design of traffic calming improvements on Via Del Monte. Although the City Manager has authority to approve professional services agreements up to \$15,000, given the interest in and importance of this subject, staff wanted to be certain this agreement is consistent with the direction provided to staff by the City Council at the May 24, 2011 meeting.
- 2. Provide alternate direction to staff.
- 3. Decline to act.

# **Recommendation from Staff**

Staff recommends the City Council approve a professional services agreement in the amount of \$9,800 to the KOA Corporation for the review and engineering design of traffic calming improvements on Via Del Monte.

# **Background and Overview**

With the adoption of the FY 2011-12 budget, which represents the City's financial plan, this report outlines the departments' operational plans for the fiscal year. FY 2011-12 represents the third year the work program is being presented to the City Council and the public. It is posted and available on the City's website.

The purpose of the work program is to highlight major department activities. It is a planning tool for the departments and one of the means by which the Council may evaluate progress as we move through the year. A mid-year update will be provided indicating completed items, revised target dates and any new, unanticipated projects that arise during the course of the first six months. Staff is aware there is City Council interest to hold a policy retreat. It is possible items identified as a result of such a meeting will be added to this year's work program. In that event, an update prior to mid-year may be appropriate.

## **Highlights of Work Program**

The departments continue to focus on major initiatives intended to ensure the City is operating under best governmental/business practices and current legal requirements. Tasks included as part of this effort are the review and revisions to the Municipal Code; Personnel Rules; Administrative Regulations Manual, Police Department Manual, Risk Management Safety Programs and our standard contracts templates. Another major focus is quality of life/safety efforts, which include emergency preparedness (DDP); PVE Cares; new refuse contract specifications and award; capital improvement projects and the City's green program. Lastly, tasks ensuring the City's continued fiscal health comprise the balance of the work program.
