#### The Issue

Should the City Council approve Resolution 08-33 related to the Planning Commission's decision concerning NC-1226RII-08; Revised Neighborhood Compatibility Grading application for additions to the single family residence located at 4101 Via Picaposte, with modification?

## **Background and Analysis**

This project consists of a Revised Neighborhood Compatibility application for additions to the single family residence located at 4101 Via Picaposte. This application requests after-the-fact approval for two new chimneys: one chimney is towards the west elevation and one is towards the north elevation. Please note that these chimneys were denied by staff in December 2007 due to the concerns the Planning Commission expressed regarding the height and massing of the project. No changes to the approved floor area, building height, or lot coverage are proposed at this time.

Following the Planning Commission review of the revised project, the City Council set this item for Public hearing on September 9, 2008 per Section 17.04.100 (E)(2) of the Palos Verdes Estates Municipal Code. The procedures for which are the same as those for an appeal of the project.

On October 14, 2008 the City Council conducted a public hearing to consider NC-1226RII-08; Revised Neighborhood Compatibility Grading application for additions to the single family residence located at 4101 Via Picaposte.

After considering the facts and testimony, the City Council voted 4-0 (Goodhart absent) to grant in part and deny in part the action of the Planning Commission granting approval of NC-1226RII-08; Revised Neighborhood Compatibility Grading application for additions to the single family

residence located at 4101 Via Picaposte, with the exception of the north chimney, which was denied.

This resolution confirms that decision.

## The Issue

Should the City Council:

1) Accept as complete the construction contract PW 542-08; FY 2008/09 City Overlay Project in the amount of \$545,124.08; and

2) Direct the City Clerk to file the Notice of Completion, and release the 10% retention 30 days after the County Recorder's office records the Notice of Completion, if no stop notices are filed?

# **Background and Analysis**

On July 8, 2008, the City Council awarded a Contract in the amount of \$536,999.28 to Hardy and Harper, Inc. for the completion of the FY 2008/09 City Overlay Project. The project consisted of removing and replacing deteriorated asphalt, edge grinding, and overlaying the street surface with new asphalt. The following streets were overlaid:

A flowline was also created down the street centerline of Navajo Place from just west of 3637 Navajo Place to 3661 Navajo Place. The flowline will direct storm runoff away from houses on the east side of the street that have reported flooding issues.

The project has now been satisfactorily completed in the amount of \$545,124.08. Additional tree root grinding occurred on Via Romero, eight additional manholes in the project area were raised to street level, and additional grinding was required at intersection transitions. One change order was issued for \$8,124.80 which increased the total construction cost to \$545,124.08 (+1.5%)

#### **Alternatives Available to Council**

The following alternatives are available to the City Council:

- 1. Accept as complete the construction contract PW 542-08; FY 2008/09 City Overlay Project in the amount of \$545,124.08, direct the City Clerk to file the Notice of Completion, and release the 10% retention 30 days after the County Recorder's office records the Notice of Completion, if no stop notices are filed.
- 2. Decline to accept the project as complete.

#### **Recommendation from Staff**

Staff recommends that the Council:

- 1) Accept as complete the construction contract PW 542-08; FY 2008/09 City Overlay Project in the amount of \$545,124.08; and
- 2) Direct the City Clerk to file the Notice of Completion, and release the 10% retention 30 days after the County Recorder's office records the Notice of Completion, if no stop notices are filed.

# **Fiscal Impact**

The FY 2008/09 budget allotted \$589,000 for the overlay of City streets. These are the project costs:

Inspection/Administration	\$37,000.00

The project budget is therefore sufficient to cover the total construction cost of \$582,124.08 shown above.

FOR THE MARCH 3, 2009 GENERAL MUNICIPAL ELECTION AND ESTABLISHING A DEPOSIT FEE FOR THE ESTIMATED COSTS ASSOCIATED WITH THE PRINTING OF CANDIDATE STATEMENTS

#### The Issue

Shall the City Council confirm Resolution R96-47 or alternately, direct staff to prepare a Resolution for purposes of governing the provisions for candidate statements for the 2009 General Municipal Election and establish a deposit fee for the estimated costs associated with printing the statements?

#### **Background and Analysis**

- 1. Section 13307 of the Election Code of the State of California provides that each candidate for local elective office may prepare a candidate's statement on a form provided by the City Clerk.
- 2. Candidate statements are optional, but must be filed at the same time nomination papers are filed with the City Clerk. The candidate statement is printed in the sample ballot mailed to all registered voters.
- 3. The City Clerk may estimate the cost of printing the candidate statement and establish a required deposit to be paid at the time nomination papers are filed.

If a candidate files a candidate statement, that statement is printed in English in the sample ballot that is mailed to all voters. In accordance with state law, a candidate may request that the statement be translated and printed in Spanish. In addition, as a result of the Federal Voting Rights Act of 1992 and due to the composition of the resident population, candidate statements are required to be translated and printed in Chinese. We have fulfilled this requirement by providing a statement on the sample ballot that a Chinese translation is available and will be mailed upon request to those who contact City Hall.

Since the implementation of foreign language translation requirements, the City Council determined that candidates should not bear the cost of the federally mandated Chinese translation and printing. During the 2007 election, the cost for the candidate information in the Chinese sample ballot (which was photocopied and distributed upon request) totaled ~\$3,000. The City's

position in the past, and as contained in Resolution R96-47, is to require candidates to pay for the Spanish translation (~\$200), since this is performed at the candidate's option, but not for the cost of the printing. No candidate during the tenure of the current City Clerk has requested a Spanish translation.

The deposit in 2007 for printing of the candidate statement in English was set at \$275 staff is recommending the same deposit for 2009. If the cost exceeds this amount, the City Clerk may bill the candidates a pro-rata share. If the cost is less, a refund can be issued.

#### Fiscal Impact

The City has budgeted a total of \$30,000 for the 2009 election services, which assumes the city would bear the cost of the Chinese translation and all foreign language printing. A revenue offset for candidate statement fees in the amount of \$1,000 is included in the FY 08-09 budget.

# Alternatives Available to the City Council

- 1. Revise the City's policy with respect to foreign translations and printing as required by the federal voting rights act and require candidates to bear these costs and direct staff to prepare a new resolution and deposit fee.
- 2. Do not change the City's past election policy with respect to the cost for foreign language translations and printing and reconfirm Resolution R96-47 as governing provisions for candidate statements and costs. If this option is selected, the deposit fee for candidate statements should be set at \$275, which would cover the anticipated cost of printing the candidate statements in English in the sample ballot. If a candidate wishes their statement translated and printed in Spanish, the City Clerk will bill the candidate directly based on actual cost for the Spanish translation.

#### Recommendation

It is recommended that the City Council confirm Resolution R96-47 as the governing provisions for the Candidate Statements and establish the candidate statement deposit fee in the amount of \$275 for the March 3, 2009 General Municipal Election.

#### The Issue

Shall the City Council adopt Resolutions R08-30 and R08-31 relating to the City's General Municipal Election to be held on March 3, 2009?

## **Background and Analysis**

The City's General Municipal Election will be held on Tuesday, March 3, 2009. In order to comply with the Elections Calendar, the process must begin with the adoption of certain resolutions as follows:

- 1. Resolution R08-30 calling for the election of two members of the City Council and the City Treasurer.
- 2. Resolution R08-31 requesting the Los Angeles County Board of Supervisors to have the County Registrar/Recorder provide certain election services.

The Elections Code governs the dates of the election calendar. The period Monday, November 10, 2008 through Friday, December 5, 2008 at 5:00 PM is established as the dates for filing of nomination papers with the City Clerk. If an incumbent fails to file by the December 5th deadline, the filing period for that office will be extended five days to 5:00 PM on Wednesday, December 10th.

Nomination papers may be taken out and returned during normal city business hours, 8:00 AM to 5:00 PM, Monday through Friday. During the filing period, City Hall will be closed Tuesday November 11 in observance of Veteran's Day; Thursday, November 27th, and Friday November 28th in observance of Thanksgiving.

The Los Angeles County Registrar/Recorder provides data processing, voter registration information, consolidation of precincts, verification of signatures and miscellaneous voter services to the City and our elections consultants, Martin & Chapman. The City must adopt a resolution requesting that the County provide these services. Costs for the County services

during the 2007 municipal election, excluding reimbursement of costs from the City of Los Angeles for consolidation, totaled \$1,009.

# Fiscal Impact

The City has budgeted \$30,000 for services related to conducting the 2009 General Municipal Election, which includes the services of Martin & Chapman, printing and mailing of a sample ballot to all registered voters, processing of absentee ballots, County services and Election Day services. This budget assumes cost sharing with the City of Los Angeles for conducting their consolidated election for the Community College District Board of Trustees.

The costs associated with the 2007 Municipal Election totaled \$42,260, excluding reimbursement of costs from the City of Los Angeles for conducting the consolidated election. The net cost to the City, after reimbursement, totaled \$24,215 (\$2.17/registered voter).

CONSOLIDATE THE PRIMARY NOMINATING AND SPECIAL ELECTIONS FOR MEMBERS OF THE COMMUNITY COLLEGE DISTRICT BOARD OF TRUSTEES, WITH THE GENERAL MUNICIPAL ELECTION OF THE CITY OF PALOS VERDES ESTATES TO BE HELD MARCH 3, 2009

AND ADOPTION OF RESOLUTION R08-32

#### The Issue

Shall the City Council agree to a request to consolidate the Primary Nominating and Special Elections of the City of Los Angeles with the City of Palos Verdes Estates' General Municipal Election to be held on March 3, 2009 and adopt Resolution R08-32?

#### Background and Analysis

Due to a charter amendment, the City of Los Angeles primary election falls on the same day as other municipal elections in Los Angeles County. The City of Los Angeles also conducts elections on behalf of the Los Angeles Unified School District and the Los Angeles Community College District.

Since 2003, the City of Palos Verdes Estates has agreed to a request from the City of Los Angeles to consolidate the LA Community College District Board election with our municipal election. The Community College District encompasses 100% of the jurisdictional boundaries of Palos Verdes Estates and thus, the City of Los Angeles has again requested that their election, which involves a nomination election for three members of the Community College District Board of Trustees (Districts 2, 4 & 6) and a special election to fill an unexpired term for District 7, be consolidated with the City's March 3, 2009 election. A copy of the resolutions from the City of Los Angeles requesting the consolidation is attached.

The City has not experienced any difficulties in conducting a consolidated election and the City has reaped significant benefit in that we are able to share costs for conducting the election with the City of Los Angeles. A consolidated election, in which all candidate names appear on the same ballot, is also less confusing to voter who otherwise would cast two separate ballots at their CITY COUNCIL AGENDA

same polling location. In 2007, there were ten candidates for four seats on Community College District Board.

City of Los Angeles election regulations do not permit candidate statements for the Community College District Board. The only information that will appear in the City's Sample Ballot, which is election information mailed to all voters, is the listing of the candidates' names by district for the Community College election. Thus, it is not likely that Palos Verdes Estates offices would be "lost" or diminished by information related to the Community College District election.

In the event the City cancels its election due to non-contested seats, meaning the number of filed candidates equals the number of available offices, the City will notify the City of Los Angeles, which will then conduct their election within Palos Verdes Estates for the Community College District Board.

#### Alternatives Available to the City Council

- 1. Consent to consolidation with the City of Los Angeles for purposes of conducting a consolidated election and adopt R08-32.
- 2. Decline to agree to the request to consolidate. Under this scenario, the City of Los Angeles will run a concurrent election using the same polling locations as the City's election, but with shared poll workers, separate ballots and separate absentee ballot process for all voters within the City of Palos Verdes Estates.

#### **Budget Impact**

If the City Council agrees to consolidation, the City of Palos Verdes Estates will be able to charge the City of Los Angeles for related election costs. The City has budgeted \$30,000 to cover the cost of this election, which assume consolidation with Los Angeles and cost sharing for the election. As a result of the consolidation in 2007, the City received a reimbursement of more than \$18,000 from the City of Los Angeles and a net election cost of approximately \$24,000 to Palos Verdes Estates.

#### Recommendation

It is recommended that the City Council accept the request to consolidate the City of Los Angeles Primary Nominating and Special Elections for the Los Angeles Community College District Board of Trustees with the City of Palos Verdes Estates General Municipal Election of March 3, 2009 and adopt Resolution R08-32.
